## COMMENTS:

Sample results were received on September 26, 2016. These results were analyzed and all variations to Table 910-1 were noted. TPH values for the 3 re-sampled locations were all below threshold values. The additional samples collected from location 4B are not within parameters and additional remediation will be required. Grynberg Petroleum Company requests at this time to backfill the areas of the excavation that require no further remediation action. This request is made for 2 reasons. The continued progress of the remediation of this project with reference to weather and planting timing and removing the soil stockpiles to facilitate access to sample location 4B for remediation activities.
