Noble Energy, Inc. ("NEI") is planning to drill the captioned boundary well in accordance with the provisions of COGCC Rule 318A.e.

NEI's proposed wellbore spacing unit consists of the Sec 20: SE/4SE/4, Sec 21: SW/4SW/4, Sec 28: W/2W/2, Sec 29: E/2E/2, Sec 32: E/2E/2, Sec 33: W/2W/2, T6N, R63W, creating a 720-acre wellbore spacing unit for the Niobrara formation. NEI is not the only owner within the proposed wellbore spacing unit and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A.e.(5). Copies of the required notice letter(s) is/are on file at the NEI offices. 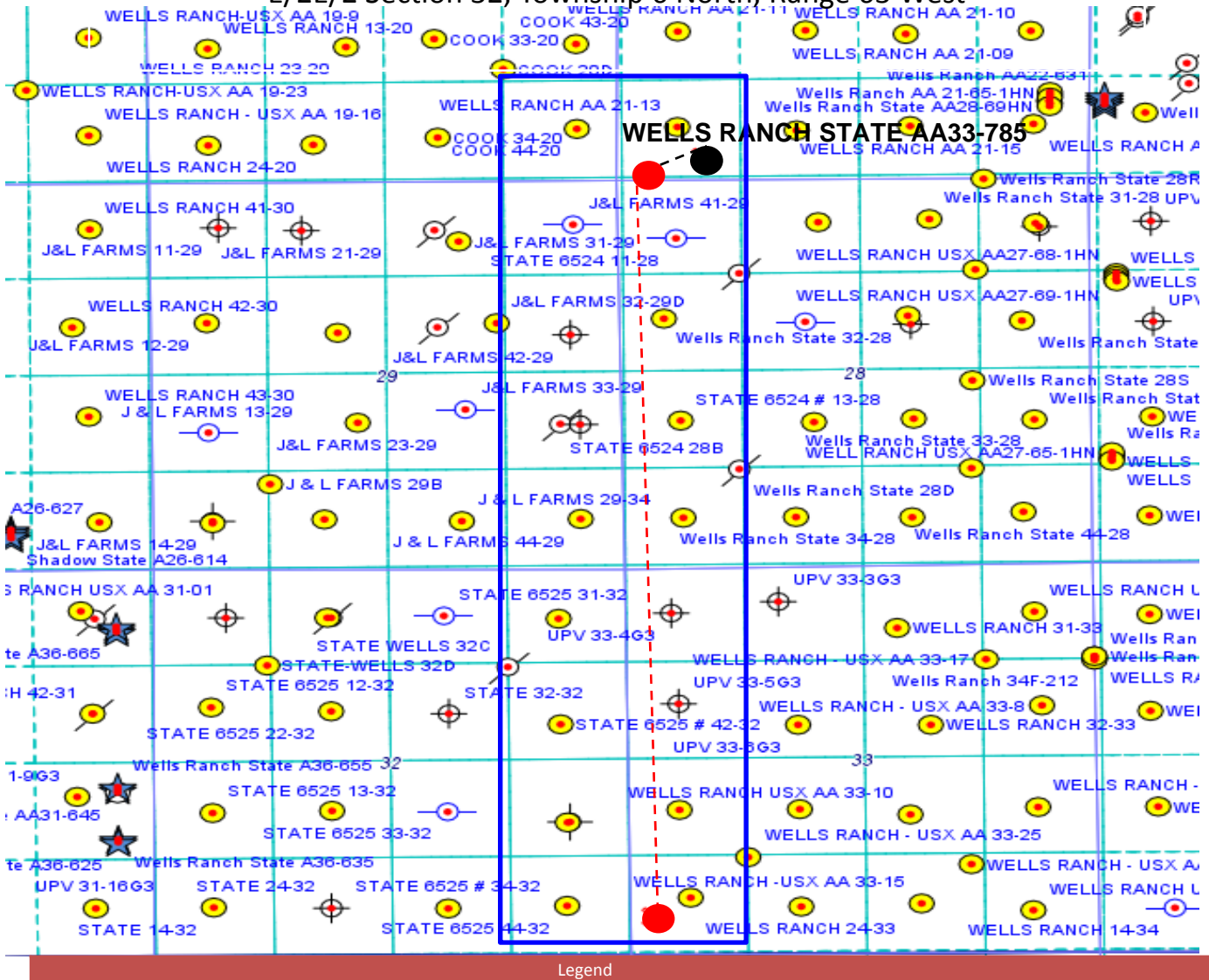

Bottom Hole Location

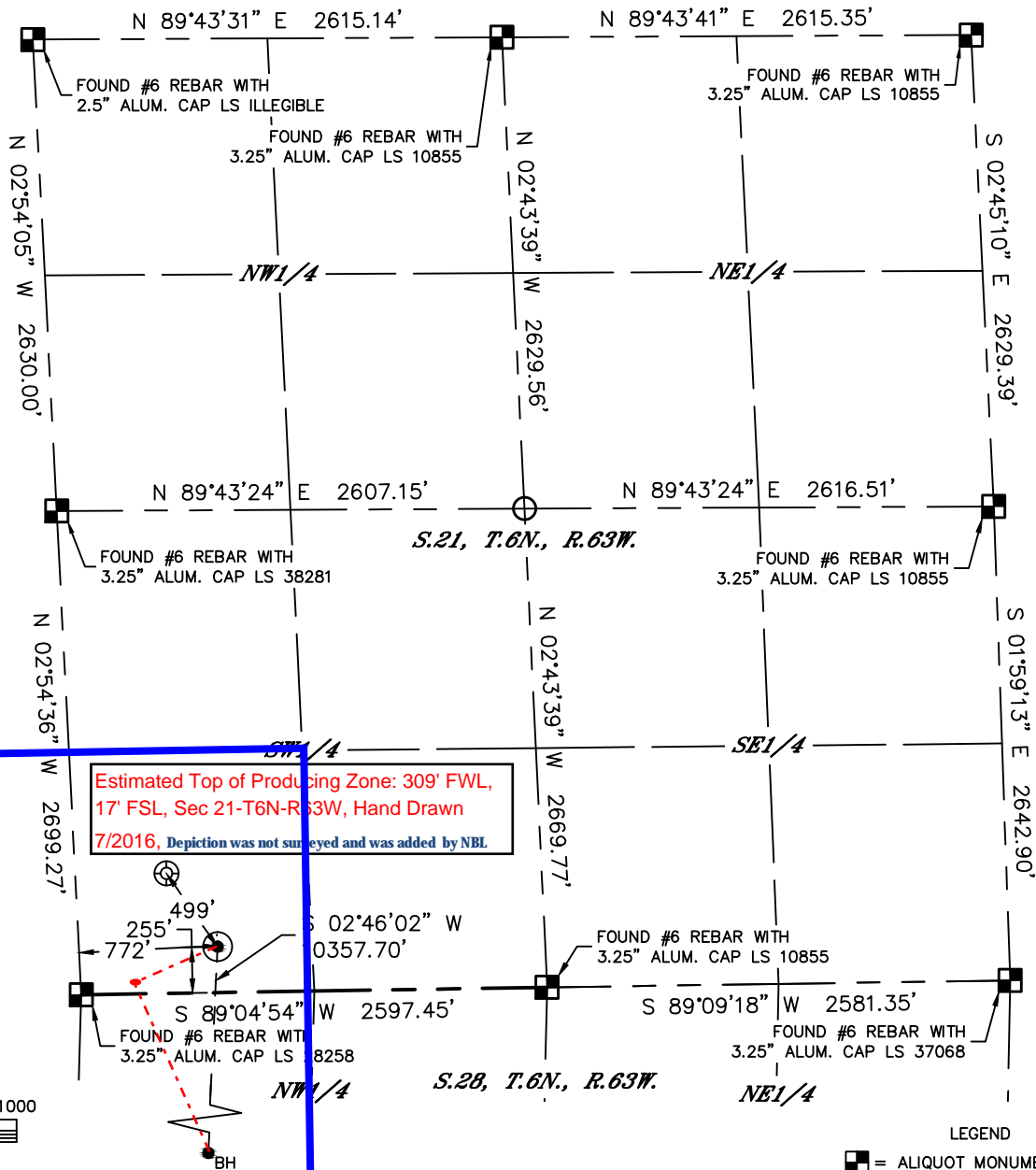

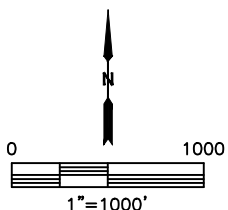
