## Memorandum of Surface Lease, Easement & Produced Water Disposal Agreement

This Memorandum shall serve as notice to all third parties that effective the 1<sup>st</sup> day of September, 2016, a Surface Lease, Easement & Produced Water Disposal Agreement ("Agreement") was entered into, by and between **Blaine L. Evans, Judy L. Evans and Evans Land Co., LLC**, whose address is 3605 Jackson County Road 26, Coalmont, Colorado 80430, (collectively called "Landowner"), and **SandRidge Exploration and Production, LLC**, with offices at 123 Robert S. Kerr Avenue, Oklahoma City, Oklahoma 73102, ("SandRidge"), which Agreement covers the existing roads located in the E/2 of Section 30-T7N-R80W together with the well pad depicted on Exhibit A located in the NE/4 SE/4 of Section 30-T7N-R80W, Jackson County, Colorado ("Subject Lands").

The Agreement grants SandRidge the right to use the Judy 1-30 well (API# 05-057-06466-00) to dispose of Produced Water and grants SandRidge right to construct, install, operate and maintain equipment and appurtenances, including pipelines, necessary to gather, transport and otherwise handle Produced Water delivered into Judy 1-30 well, together with the right of ingress and egress on, over and across the Subject Lands.


The Agreement shall remain in force for so long as SandRidge is utilizing the Judy 1-30 well for the purpose of water disposal without a cessation of twenty four consecutive months.

Both Landowner and SandRidge have possession of a fully executed copy of the Agreement. The purpose of this Memorandum is to evidence the existence of the Agreement and this Memorandum is given in lieu of filing the Agreement in full of record in the Records of Jackson County, Colorado. Any party in interest may examine the full terms of the Agreement by contacting Grantee at the address hereinabove.
