We are formally requesting that our remediation commitments associated with the project identified by Remediation Project # 9491 be put on hold due to an unstable landslide immediately up hill of the project area. Remediation commitments include the delineation of remaining subsurface impacts. This delineation would involve the utilization of an environmental drill rig which could potentially trigger the landslide or cause loose rocks/boulders to roll down onto the pad surface. After visiting the site on September 7, 2016, Carlos Lujan of the COGCC verbally approved this request.
