**This Warning Letter is to inform you that PROWERS GAS GATHERING CO LLC (“Operator”) may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission (“COGCC”) and corrective action is required.**

The COGCC has reasonable cause to believe that the Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. The Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

**Alleged Violation(s) and Required Corrective Action(s):**

302.a Registration Form 1

Description of Alleged Violation: Pursuant to Rule 302.a., Prowers Gas Gathering Co LLC (Operator) is required to File a Form 1, Registration for Oil and Gas Operations, prior to commencement of operations. Operator is required to immediately report changes of contact information by submitting a new Form 1 to COGCC. COGCC staff attempted to contact Operator by phone on October 4, 2016 and discovered the registered number, see attached Document #401130896, is no longer in service. A new Form 1 has not been submitted to update this contact information, violating Rule 302.a.

Required Corrective Action: Operator shall submit a revised Form 1, which can be found at <https://cogcc.state.co.us/forms/forms.html>, with current contact information to COGCC by US Mail or electronic mail to the attention of Martha Ramos.
