General Comment:

On October 13, 2016 COGCC Environmental Staff (Kris Neidel) conducted an environmental field inspection of DIVERSIFIED ENERGY LLC (Diversified) Urie 1 Location ID: 312771. The INSP included Pit Facility 116613, the well (API 05-081-05284), and former tank battery area. Weather was 65 degrees. Well was not producing at time of inspection, electrical disconnect box was double locked. For the most recent Field and Environmental Field inspection report of this facility, please refer to document #673403543. At the time of the inspection, corrective actions (CAs) provided in that inspection had not been addressed. The overall inspection status shall remain the same as that document until all CAs have been completed. The following is a summary: Well head: Valve at well was in lock out position, the flowline off the wellhead terminated to the pad, not blinded, open to atmosphere. Tank Battery: Tanks no longer present as indicated in Inspection Document Number 673403543. Two (2) app 6' dia concrete pads present. Vegetation (weeds) throughout. Electrical panels, electrical conduit, pipe risers, and valves present. Flow lines present west of the pad in the area of concrete pads. Pit Facility ID 116113: No indication of a pit was observed.
