Once flowlines are properly abandoned, file electronic form 42. 3) For 966' plug: pump plug and displace. If cement is not circulated to surface, shut-in, WOC 4 hours and tag plug – top of plug must be not deeper than 816' and provide minimum 10 sx plug at the surface. Leave at least 100' of cement in the wellbore for each plug.
