

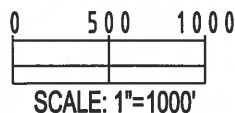
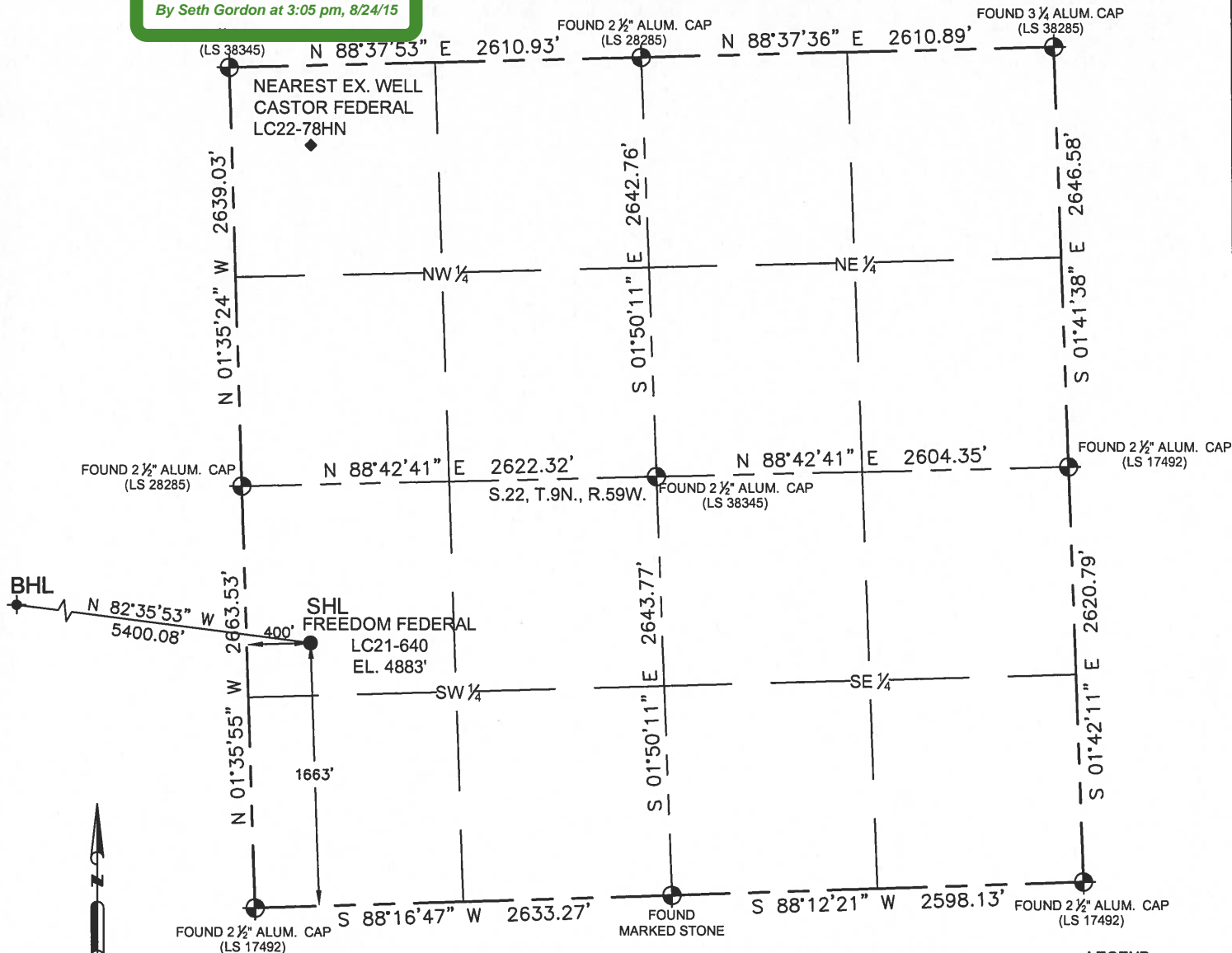

In accordance with a request from Brian James with Noble Energy Inc. Petroleum Field Services, LLC has determined the surface location of the FREEDOM FEDERAL LC21-640 to be 1663' from the SOUTH line and 400' from the WEST line as measured at right angles from the section line of Section 22, Township 9 North, Range 59 West of the Sixth Principal Meridian, County of WELD, State of Colorado, and the bottom hole to be 2530' from the SOUTH line and 330' from the WEST line as measured at right angles from the section line of Section 21, Township 9 North, Range 59 West of the Sixth Principal Meridian, County of WELD, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 04/22/14 for and on behalf of Noble Energy Inc., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for the establishment of fence, building, or other future improvement lines.

Notes:

1) Bearings shown are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2011. The lineal dimensions as shown herein are grid distances based upon the "U.S. Survey Foot." To get ground distances, multiply shown distance by 1.000240741.

2) Ground elevations are based on an observed GPS elevation (NAVD 1988 DATUM).
