Well was originally shut-in for Horizontal Safety Prep. RBP W/SAND CAP @ 7,072 and RBP W/SAND CAP @ 6,949. A mechanical integrity test was performed to ensure integrity of the casing on 10/14/16. The well will continue to be shut-in for the next 4 to 5 years waiting for an engineering review. T&A status provided via a down-hole plug and surface isolation provided via closed master valve.
