Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. This information was used in addition to locally-available geophysical logs and hydrogeologic information to evaluate the adequacy of the operator's proposed surface casing setting depth. The deepest water well within one mile is 500 feet. Review of logs and geologic mapping indicates the proposed surface casing will cover the entire Parachute Creek member of the Green River formation.
