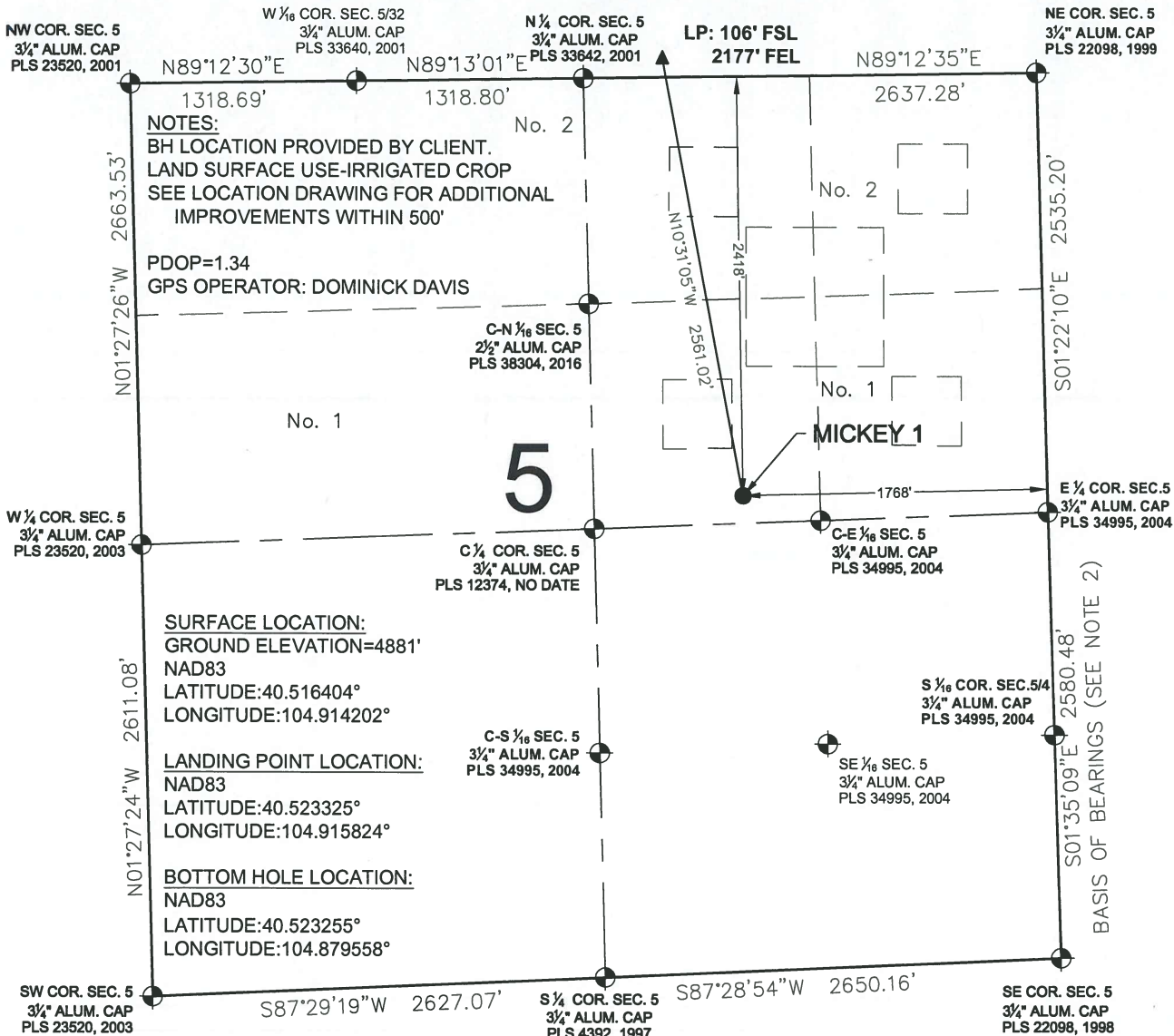


MICKEY 1 WELL LOCATION CERTIFICATE

2418' FNL & 1768' FEL



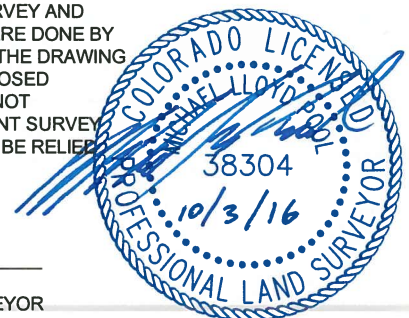

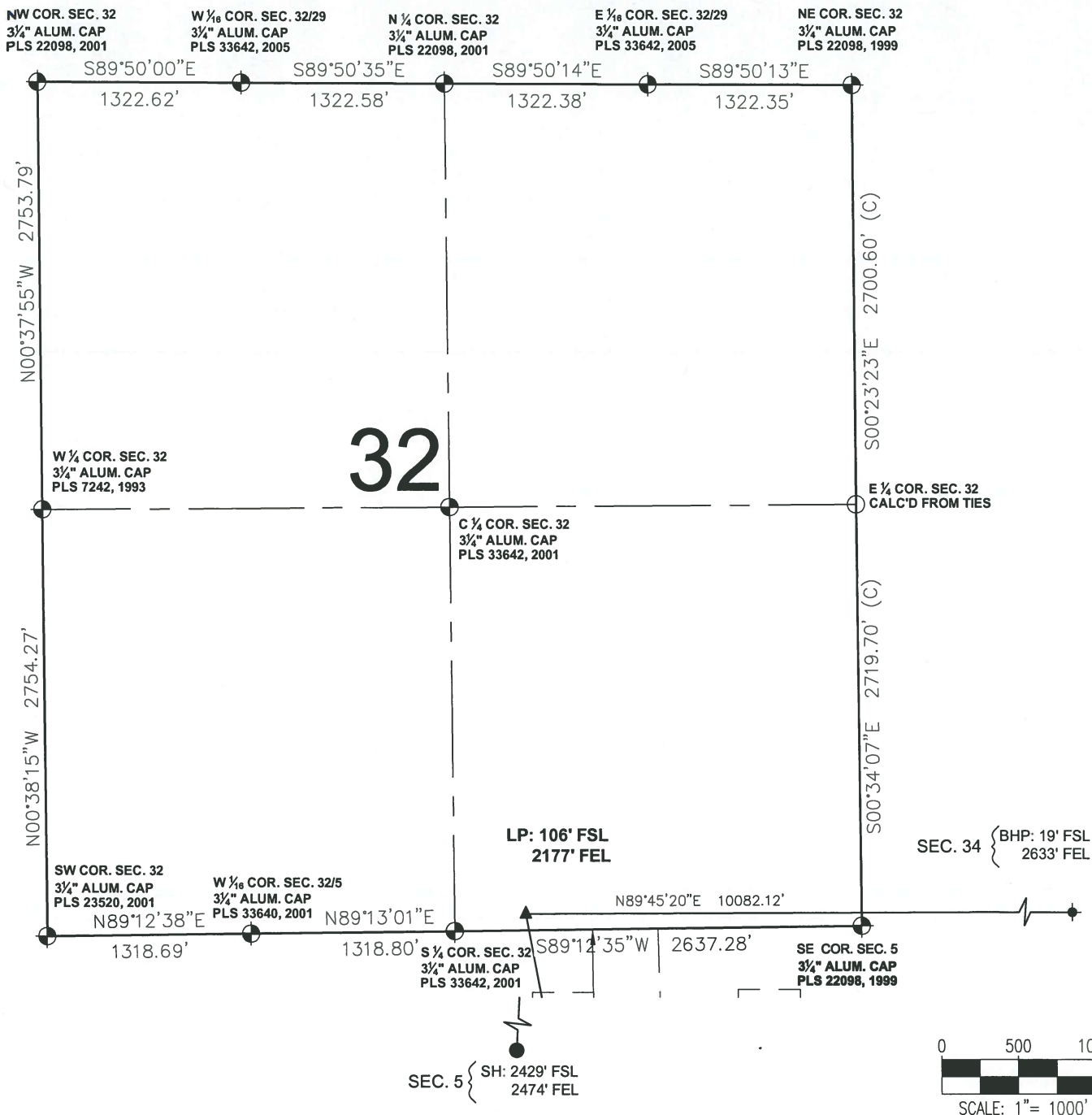

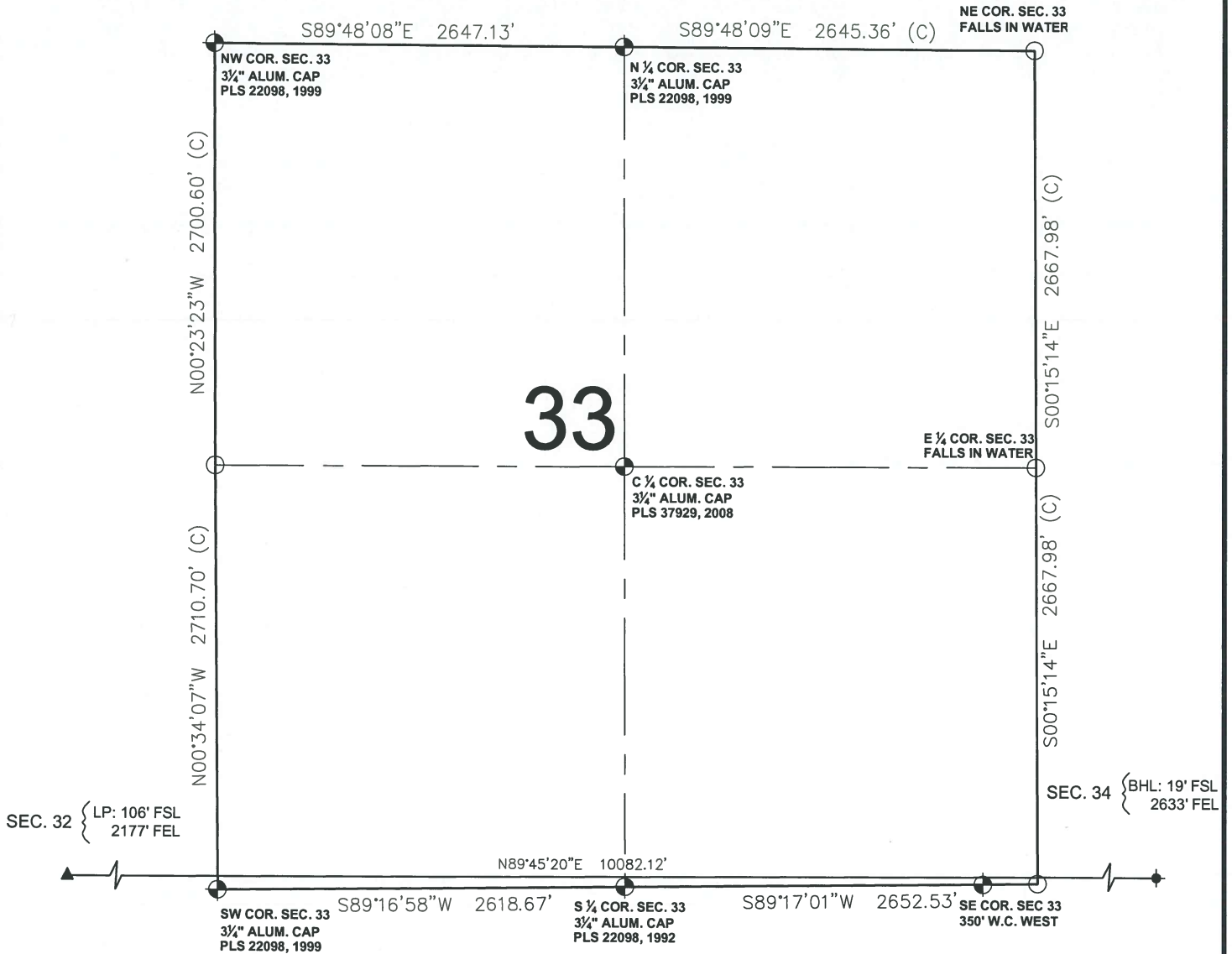

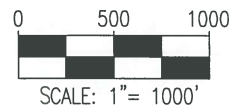
