The proposed wellbore spacing unit consists of:

- Section 32-7N-67W: S/2SE/4
- Section 33-7N-67W: S/2S/2
- Section 34-7N-67W: S/2SW/4, SW/4SE/4
- Section 3-6N-67W: Lot 2 NW/4 & Lot 2 NW/4NE/4
- Section 4-6N-67W: Lot 2
- Section 5-6N-67W: Lot 2 NE/4

The spacing unit is a 720-acre wellbore spacing unit for the Niobrara and Codell formations.

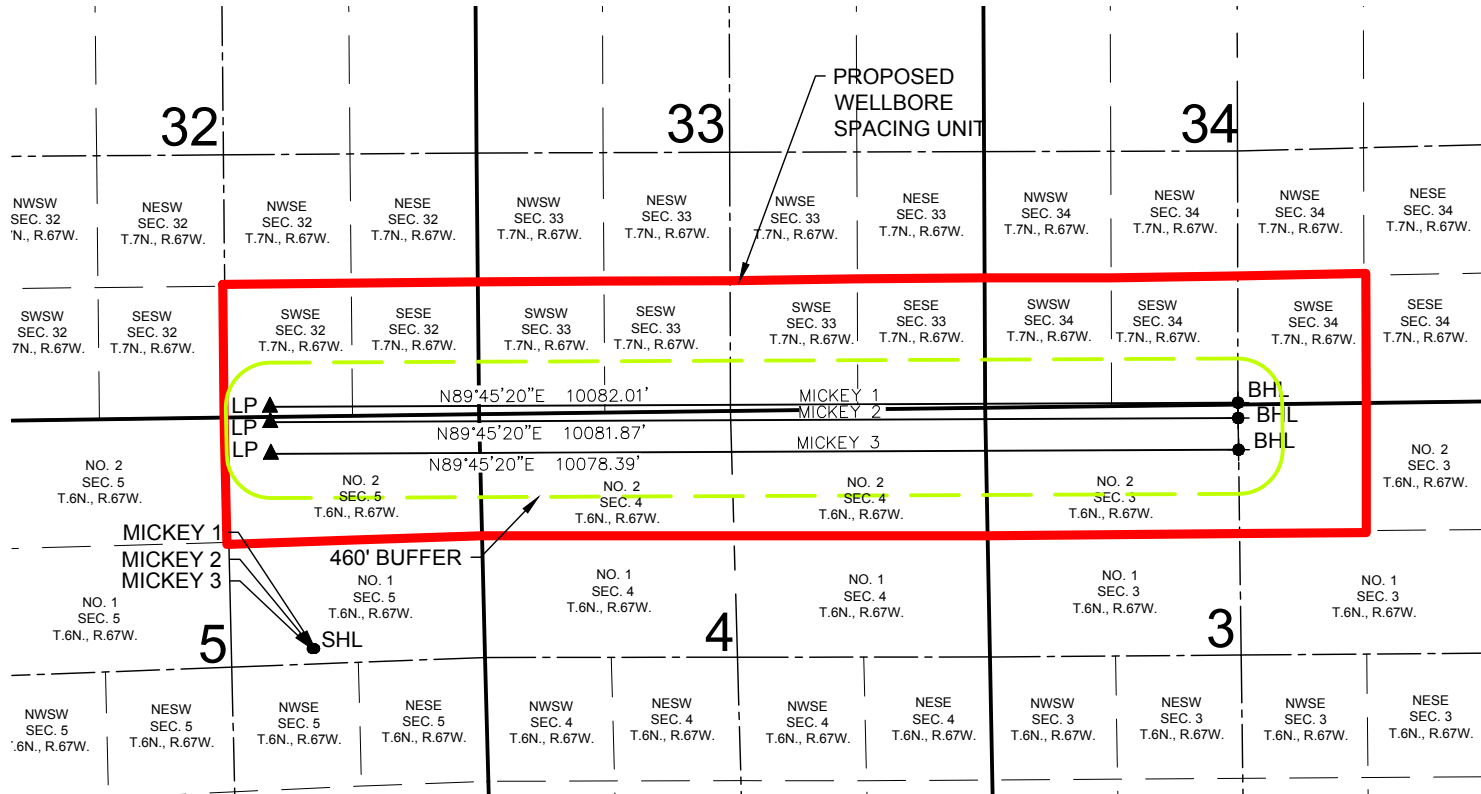

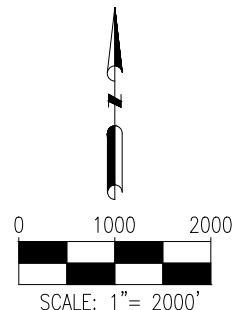
