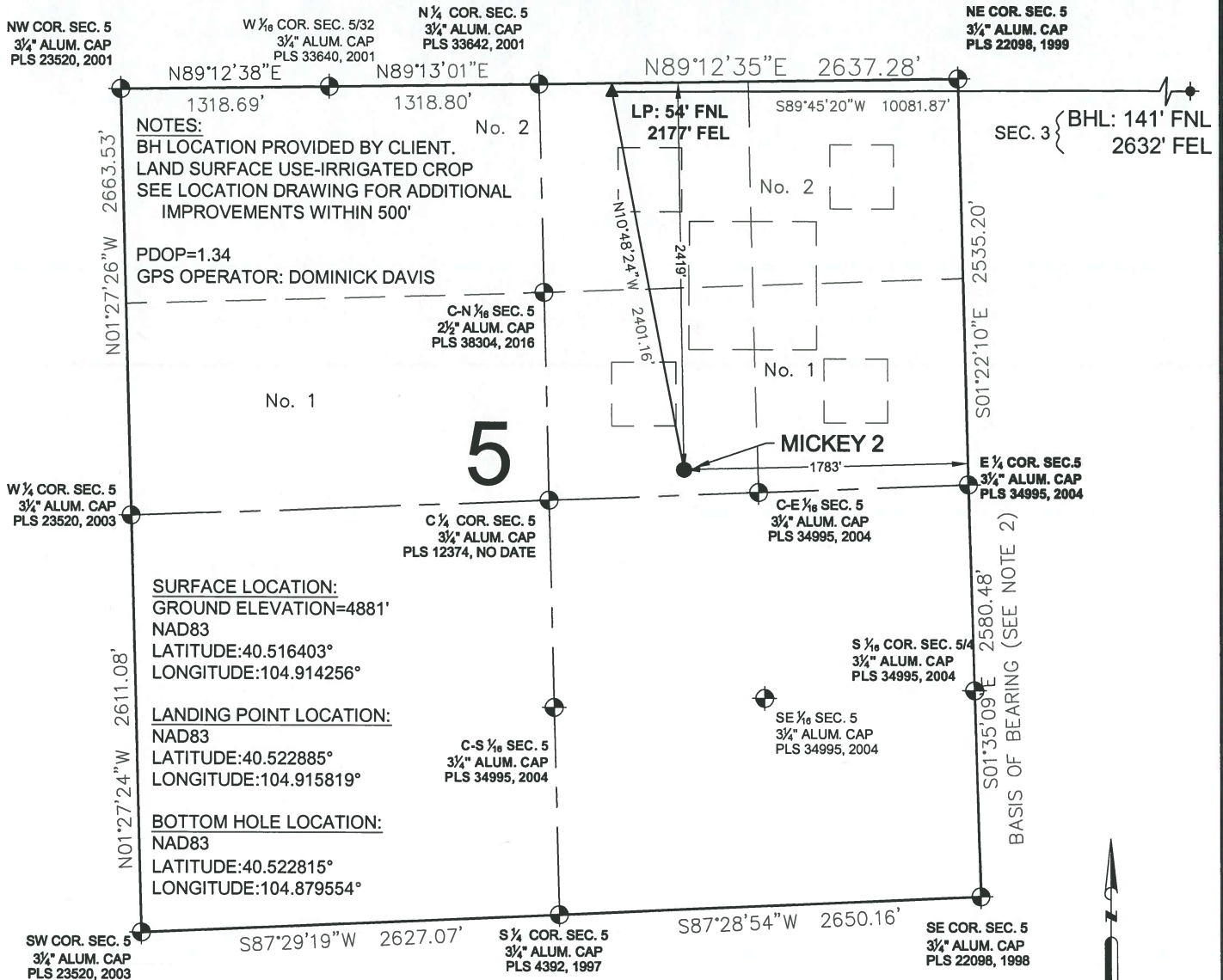


MICKEY 2 WELL LOCATION CERTIFICATE

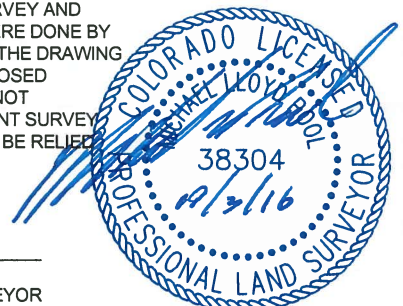

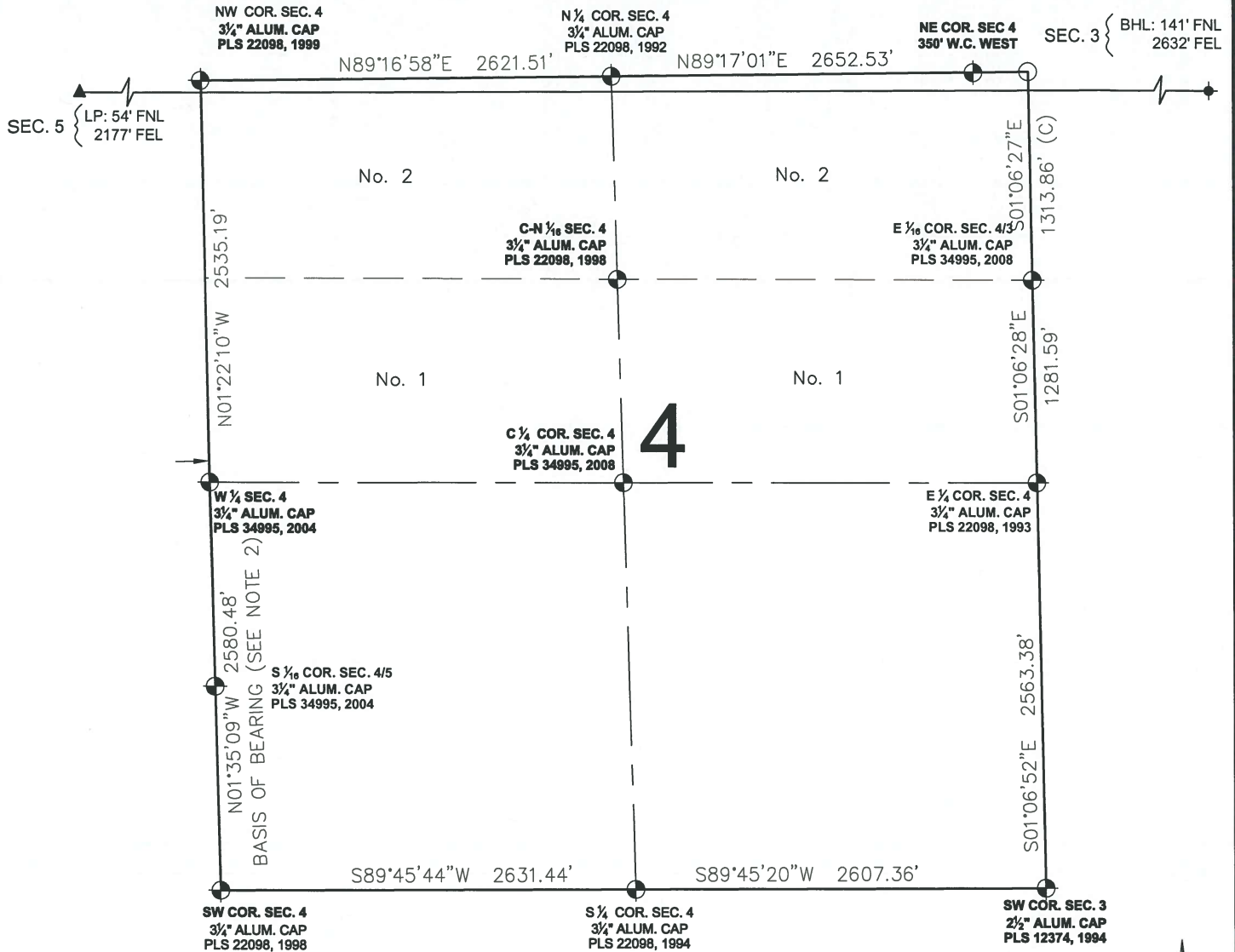

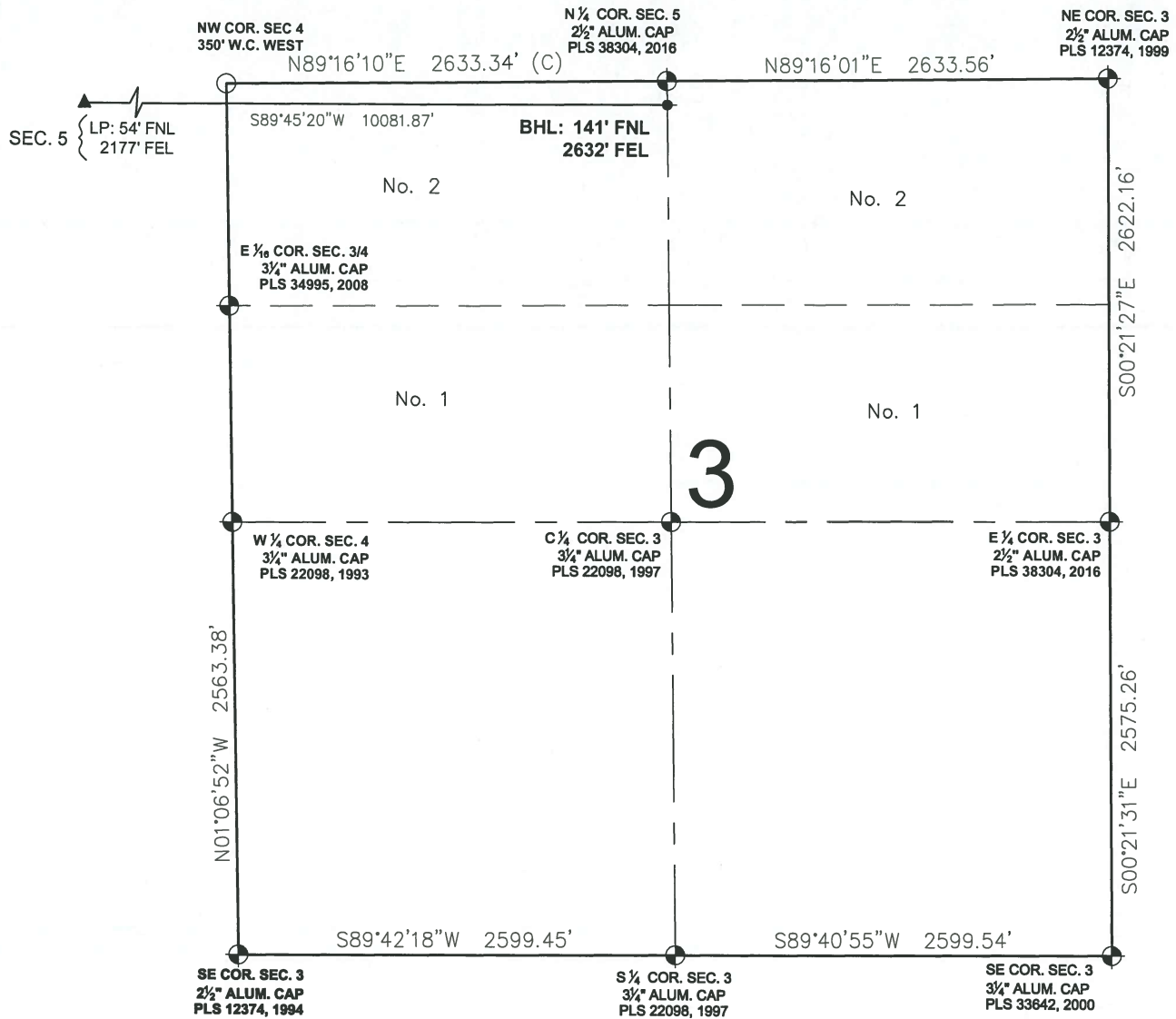
