Alex,

I looked through the data and reports we have for the PetroHunter sites. We were originally asked to help on five well sites that had NOVAs associated with them (the sites were known as 4-21, 6-16, 6-22, 13-10, and 16-21). We submitted Form 27s for these five sites. We did environmental sampling on three of the five sites. It looks like we submitted summary reports for 4-21 and 13-10.

Soil and/or water samples were also collected from 6-22. A summary report was not completed because we were waiting on Mr. Anderson to sign a letter stating he approved to have the mixed drill cuttings used as backfill for the drilling pit. Mr. Anderson gave verbal approval to White Construction to backfill the drilling pit but never signed the letter provided to him. No other work was performed at any of the PetroHunter sites.

I attached the INCOMPLETE letter report, INCOMPLETE figures and photographs, and laboratory data for 6-22. The laboratory data includes a water sample collected from a fresh water pit and soil samples from beneath the fresh water pit liner. We did not perform any additional work on PetroHunter sites following the preparation of the incomplete report.
