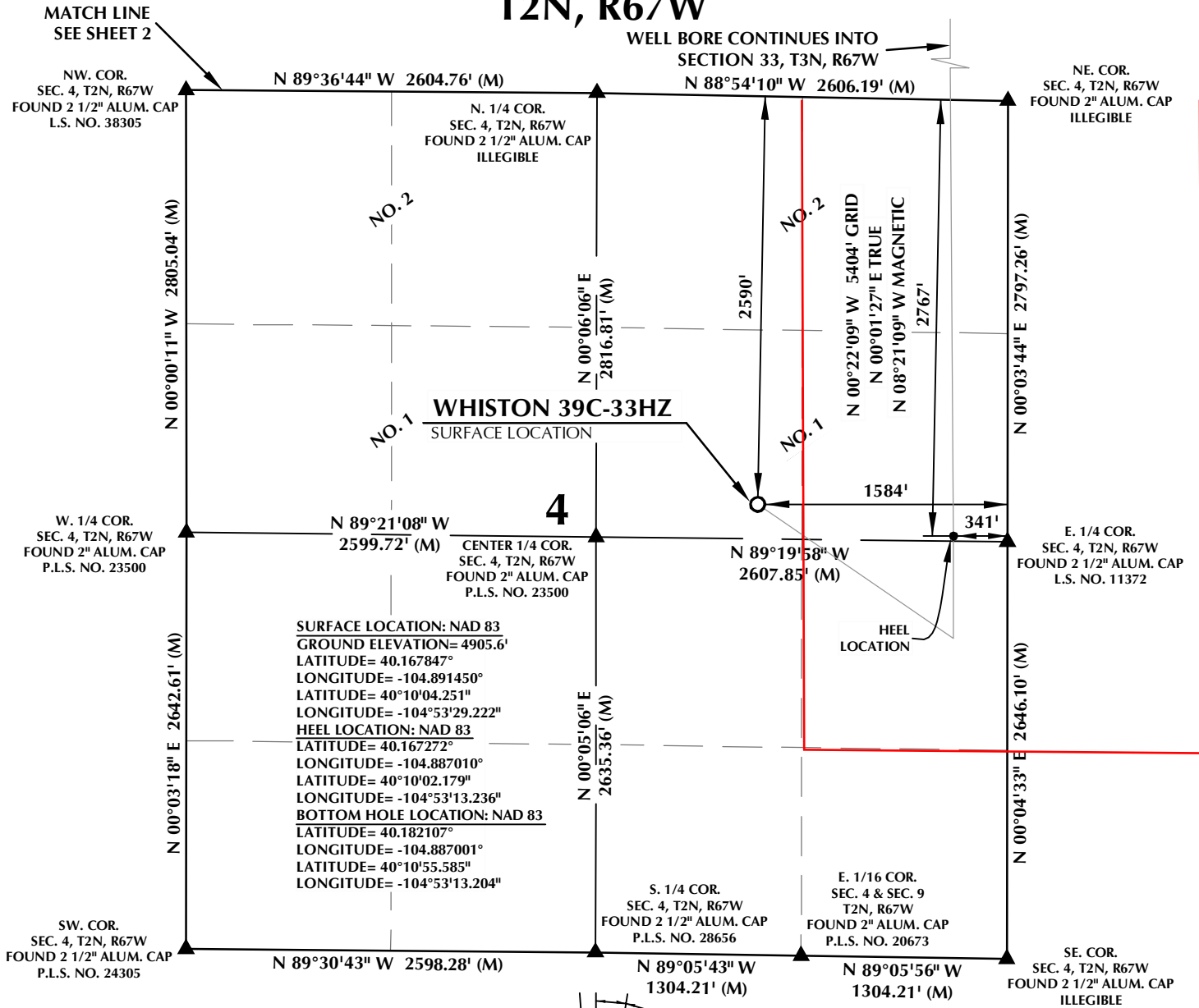

SECTION 33, T3N, R67W

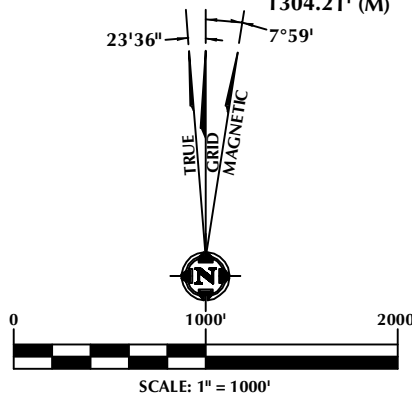

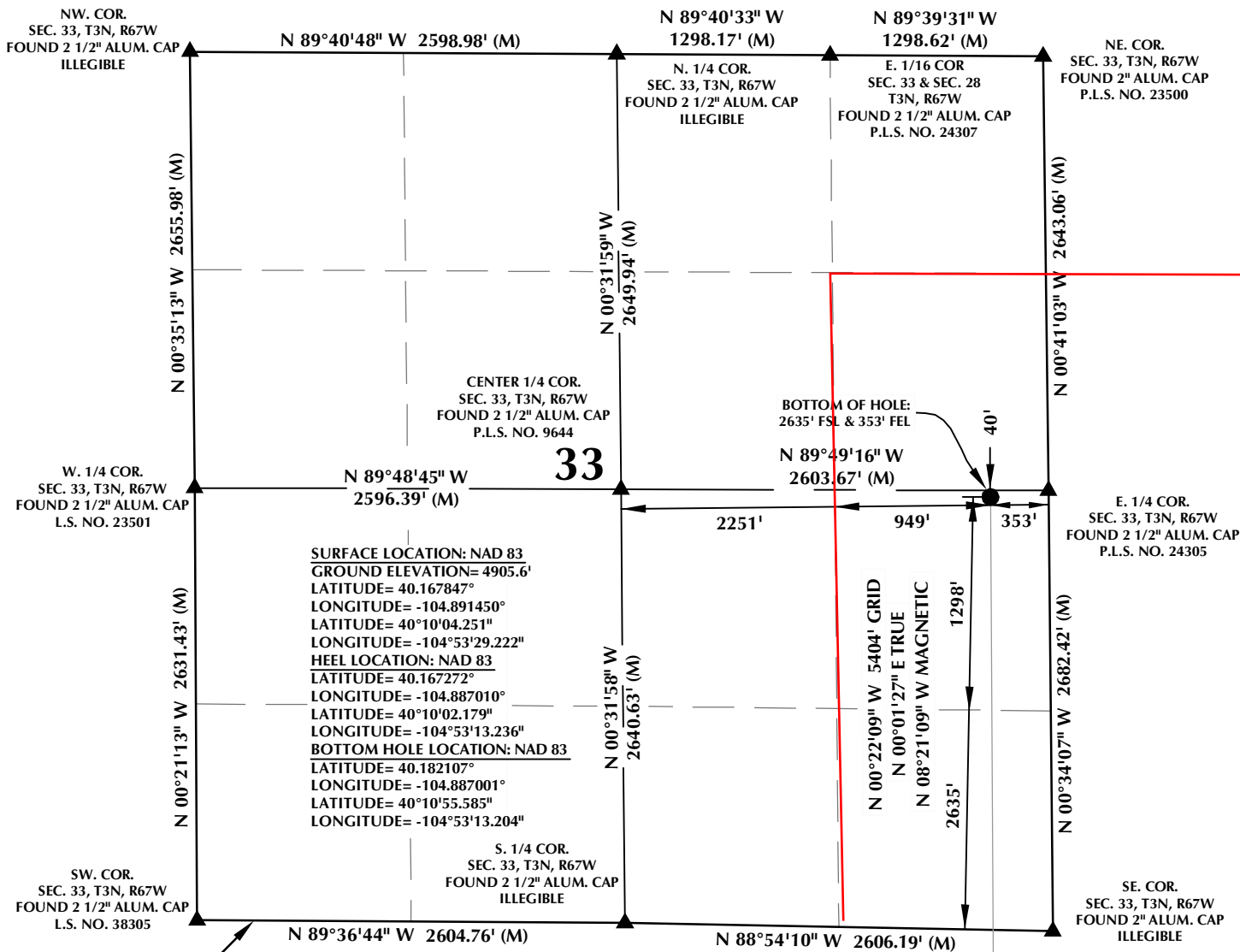

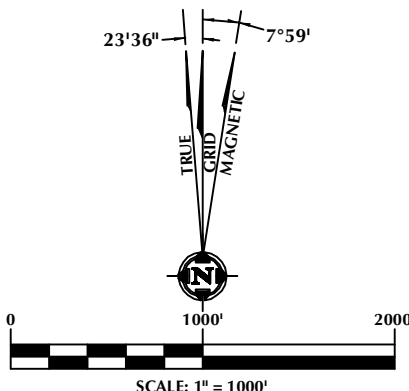
