Comment: **Location ID 319300 with the following API#123-11032 has pipeline risers at the tank battery location. All surface equipment shall be removed within three months of plugged a well. Well location meets Rule 1004 standards; however, final release will not be given per Rule 1004 until all pipeline risers are removed from location. Refer to attached photos in Document #682401400.**

Corrective Action:	Remove pipeline riser from tank battery location. Any disturbance created during the removal of these items shall be seeded with native, perennial vegetation that is reflective of reference areas. In the absence of an agreement between the operator and the affected surface owner as to what seed mix should be used, the operator shall consult with a representative of the local NRCS district to determine the proper seed mix to use in revegetating the disturbed area.
