Comment:

Location ID 329055 with the following API#123-16804 has evidence of a seeding attempt from seed drilling rows but areas throughout location still have bare patches with little to no vegetative growth that is not reflective of reference areas. However, the location appears to be heading in the right trajectory to meet Rule 1004 to achieve uniform vegetative cover that reflects reference area forbs, shrubs, and grasses with total percent plant cover of at least eighty percent (80%) of reference area levels, excluding noxious weeds. Location will be inspected the next growing season to ensure compliance with Rule 1004. Access roads remain for other active NGL facilities. Refer to attached photos in Document #682401402.
