**General Comment:**  
COGCC Environmental staff (Kris Neidel) inspected the location at the Chivington #1 on 10/25/2016. Weather was 62 deg and cloudy. Grynberg notified the COGCC on 10/24/2016 that the material that they imported for backfill may have been contaminated with trash. Upon arrival on location, Grynberg contractors had spread much of the fill material across the pad to assess the extent of foreign material that may be in the fill soil. Staff witnessed crews picking up any foreign material that was in the soil while backfilling the south side of the main pit excavation, near the area of former sample location "5". There was some foreign material (trash, pvc) in the fill soil, no foreign material was witnessed being placed in the pit. The amount of trash is estimated to be approximately one half of a trash bag. A soil sample was collected by the COGCC and will be analyzed and compared to table 910-1 values. There is a pile of soil, approximately 80yds, that was excavated from the remaining contamination in the pit that needs to be disposed of offsite (see photos for detail).
