**General Comment:**

This is a final reclamation inspection. Document 577593 describes plugging the well on November 5, 1991. A corrective action inspection on June 2, 1995 documents that 2 reserve pits were still in place and operator needs to reclaim or provide a statement from the surface owner that releases operator from the responsibility of reclaiming the pits. This letter was provided as document number 577594. Followup with COGCC Environmental Supervisor confirmed that the surface owner letter is an acceptable means to avoid reclaiming the pits due to the time since this was reviewed and that it was a response to a corrective action.
