**COMMENTS:**

This sundry is a request to change drilling plan, change casing plan, and a request to drill with oil based mud. Drilling program is being changed to monobore, therefore changing the casing and cement program. There will be no intermediate casing.  
Drilling Fluids Disposal: OFFSITE \* Method: COMMERCIAL DISPOSAL

Drilling fluids disposal: Crestone Peak Resources will reuse water-based drilling fluids to the maximum extent possible, remaining fluids will be disposed of at a licensed, commercial disposal site.  
Crestone Peak Resources will reuse oil-based drilling fluids to the maximum extent possible, remaining fluids will be disposed of at a licensed, commercial disposal site.  
Cuttings disposal: Cuttings will be solidified onsite for offsite removal to a licensed, commercial disposal facility.  
In addition, cuttings are contained in closed loop solids control equipment; they then go through shale shakers and into a three sided bin. From there, the cuttings go into a sealed container made for cuttings. The container is picked up by truck and hauled to a landfill. All equipment is contained on the ground with a 120mm liner. There is no chance of hydrocarbon migration from a rain event. The Waste Management Plan containing more complete information on disposal of drilling fluids and cuttings is attached to the sundry for location #446290, document number 401141198.
