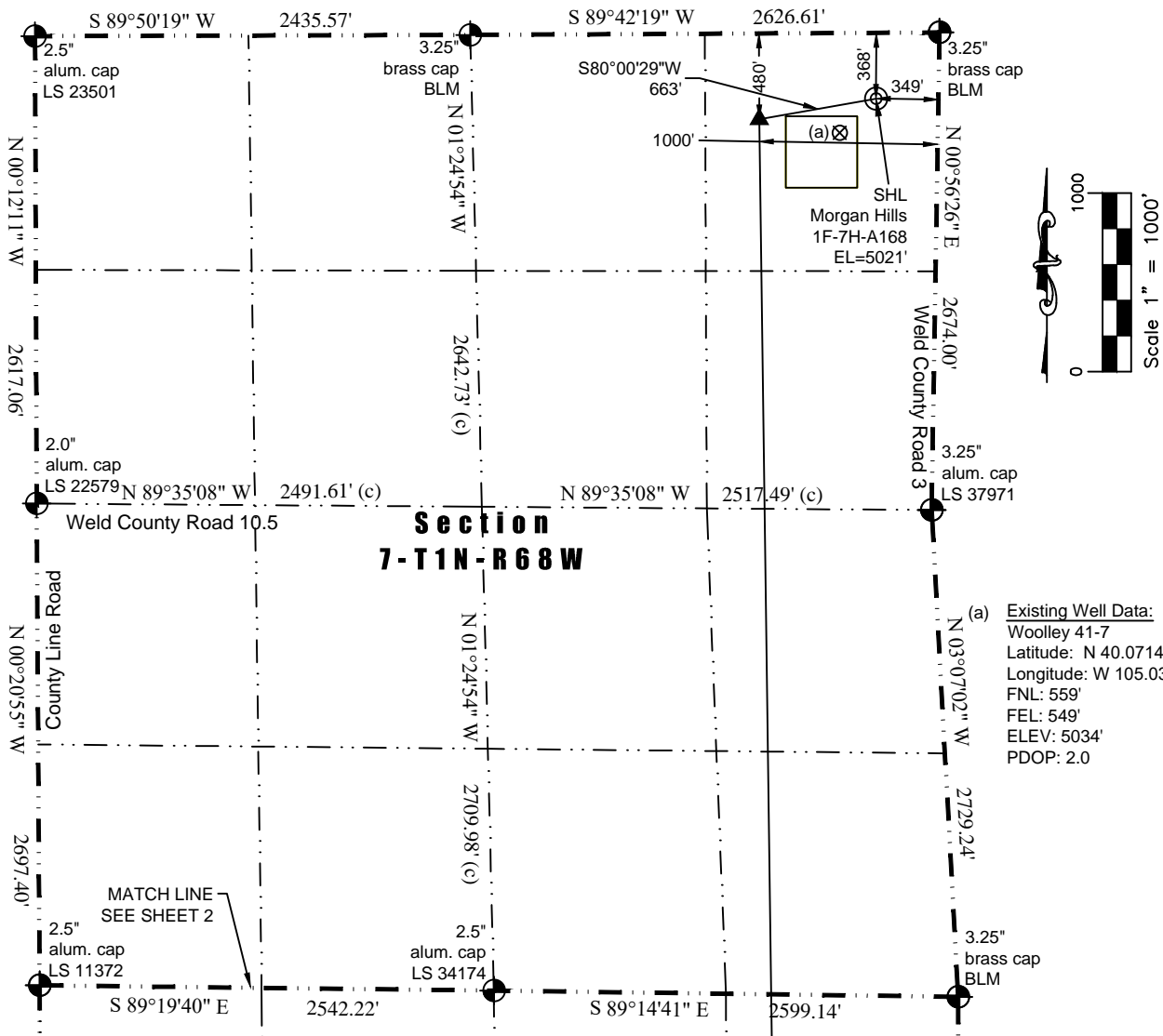

In accordance with a request from Jay Knutson of Crestone Peak Resources, Washburn Land Surveying, LLC has determined the location of the **Morgan Hills 1F-7H-A168** well site to be SHL: 368' FNL and 349' FEL, (TPZ: 480' FNL and 1000' FEL), (BHL: 470' FSL and 1000' FEL), as measured at ninety (90) degrees from the section lines of Sections 7 and 18, Township 1 North, Range 68 West of the 6th Principal Meridian, Weld County Colorado.

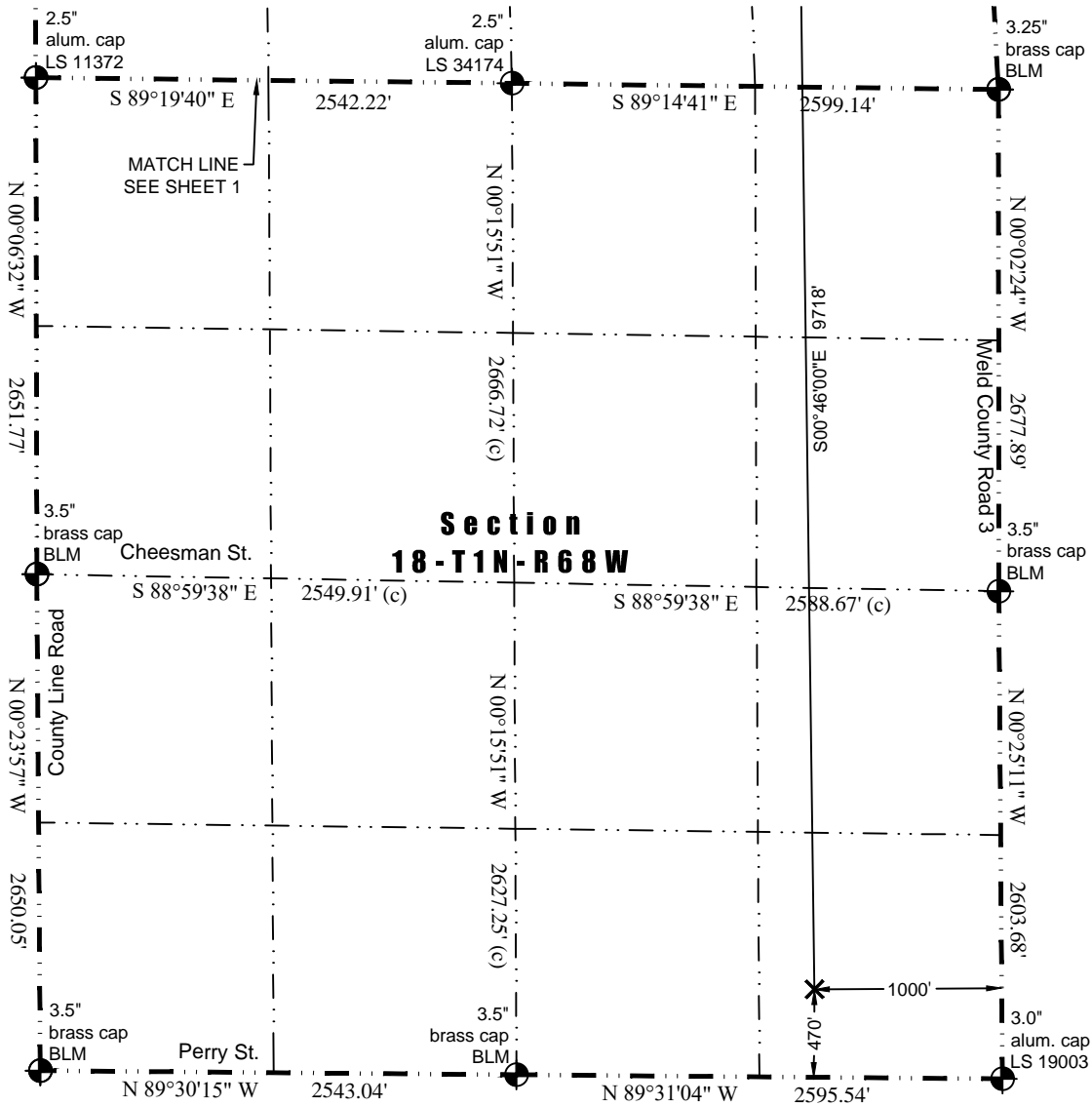

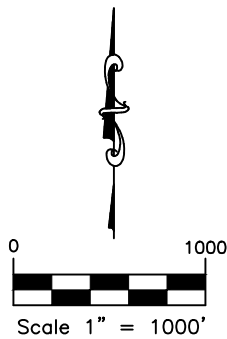
