Comment: SE corner berm has washed out allowing stormwater and sediment to run off location. NE corner cut slope has erosion channels allowing stormwater and sediment to run onto location creating silt deposit on location. SW side of location entrance has erosion channel cutting and eroding ditch. Two 55 gallon drums containing fluid with no spill prevention. Lease road is rough and washed out with erosion channels. Ditches are no longer functioning allowing stormwater and silt to flow onto road from surrounding hillside further deteriorating road condition.

Corrective Action: Install or repair required BMPs to comply with Rule 1002.f. Refer to the 1002.f guidance document for further details.
