LEASE ADDENDUM AND SURFACE DAMAGE AGREEMENT

AND, WHEREAS, Lessor and Lessee desire to enter into this Agreement to facilitate and coordinate the use of Lessor's Surface Lands for the purposes of conducting oil and gas exploration and production activities thereon consistent with the Lease, including without limitation, the identification, location, permitting and development of viable drilling pad sites, access roads, pipelines, and utility lines upon Lessor's Surface Lands or lands pooled therewith and for the purpose of settling surface damages related to such activities.

NOW THEREFORE, in consideration of the mutual covenants herein contained, and as contained in the Lease, Lessor grants to Lessee the rights, easements and agreements to utilize the Lessor's Surface Land for the purposes of conducting oil and gas exploration and production activities consistent with the Lease and in accordance with the following terms and conditions:
