Dear Director Lepore:

CAERUS WASHCO, LLC respectfully requests approval of an exception to Rule 318.A.a to allow the above named wells to be drilled at the above referenced location. Rule 318A.a. of the Colorado Oil and Gas Commission's Rules and regulations requires wells to be drilled and completed in a square with sides four hundred (400) feet in length, the center of which is the center of any quarter/quarter section or in the center of any quarter section with the four sides begin eight hundred (800) feet in length.

CAERUS WASHCO, LLC is requesting an exception to this rule based on Section 35 being an irregular section. The above listed wells are outside the GWA window. These wells are proposed outside the GWA window to maximize the production interval.

CAERUS WASHCO, LLC has provided COGCC with a signed Surface Use Agreement. CAERUS WASHCO, LLC has obtained a waiver for Rule 318A.a from the surface owner in Section 12. of the "Surface Use Agreement".
