Subject well and access road were located within an active gravel pit (see attached 2013 aerial photo). Subsequent to P&A operations in March 2014, the gravel pit was enlarged and the former well location and access road were removed (see attached 2015 aerial photo). The tank battery that serviced this well is active and currently services four producing wells: the Edith 1-26, the Irving 1-26, the Irving 5, and the Payne 2-26. The tank battery is located adjacent to the Payne 2-26 well.
