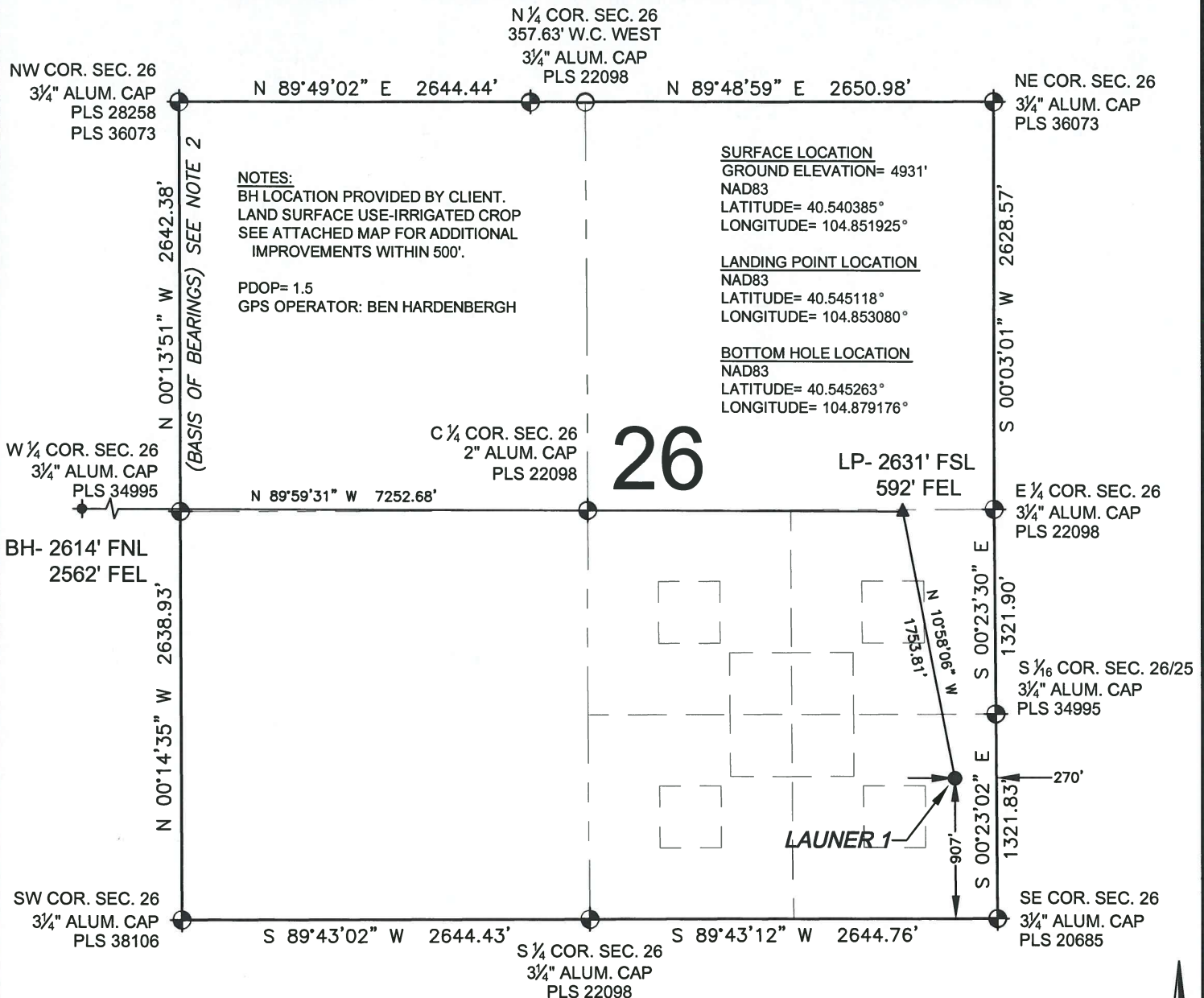


WELL LOCATION CERTIFICATE: LAUNER 1

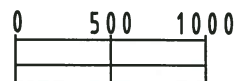

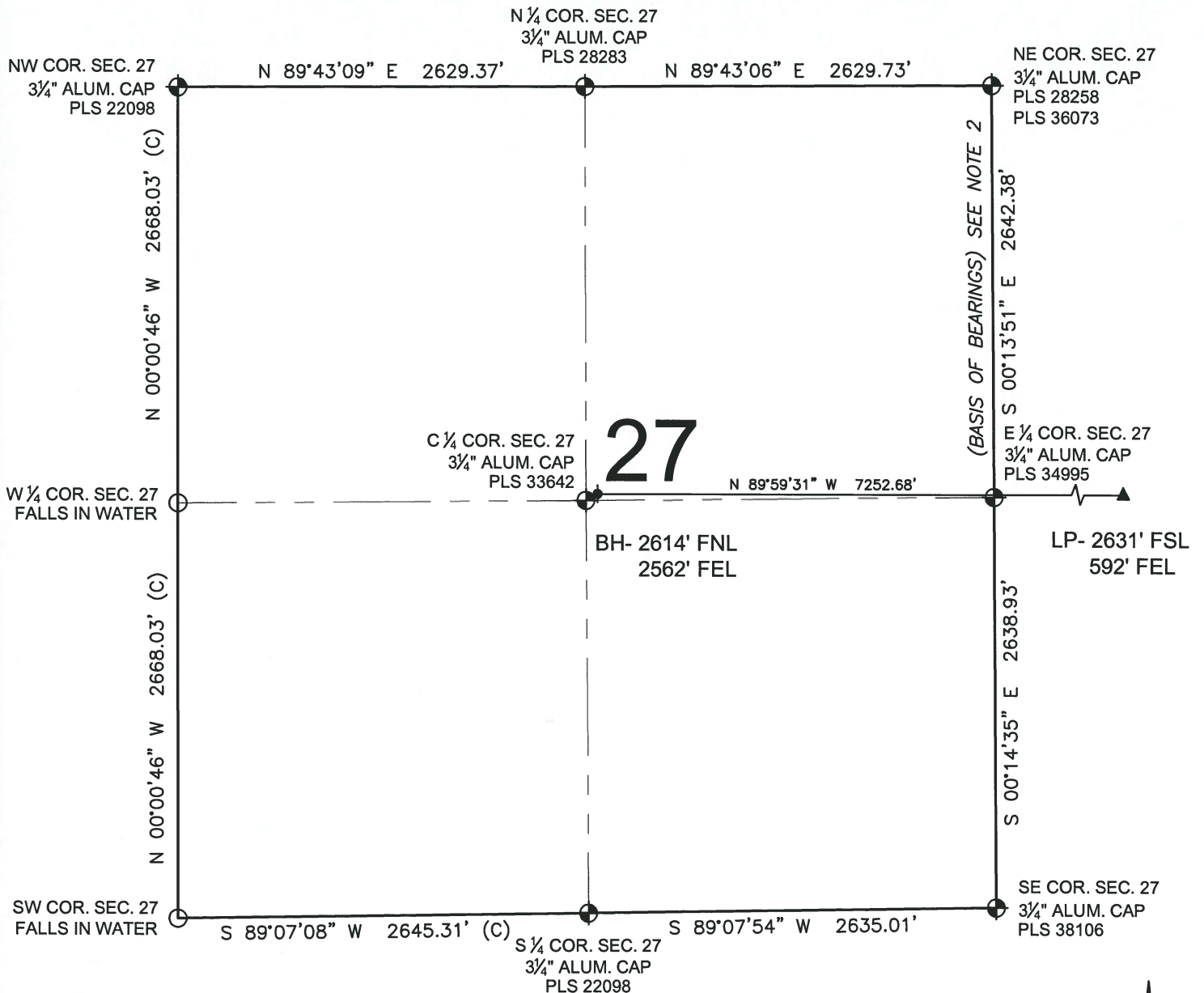
