Containing 280.00 acres, more or less.

Extraction is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(5). 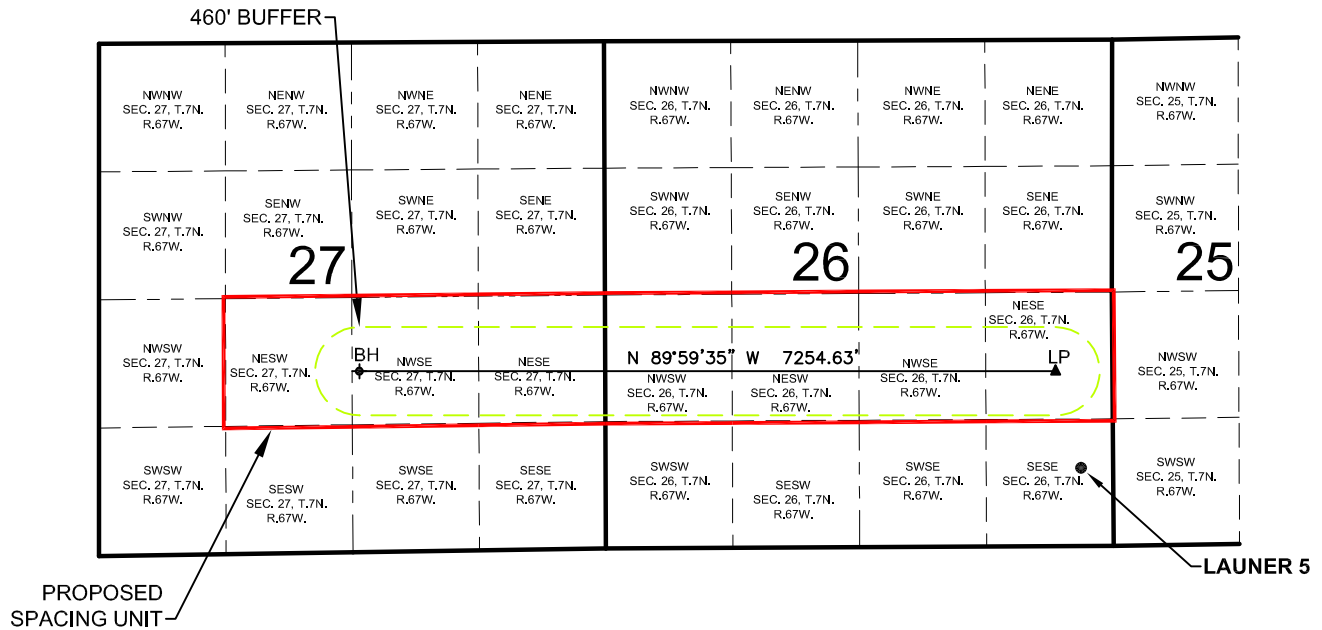

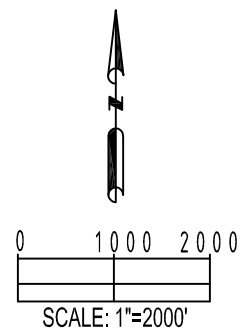
BOTTOM HOLE LOCATION
