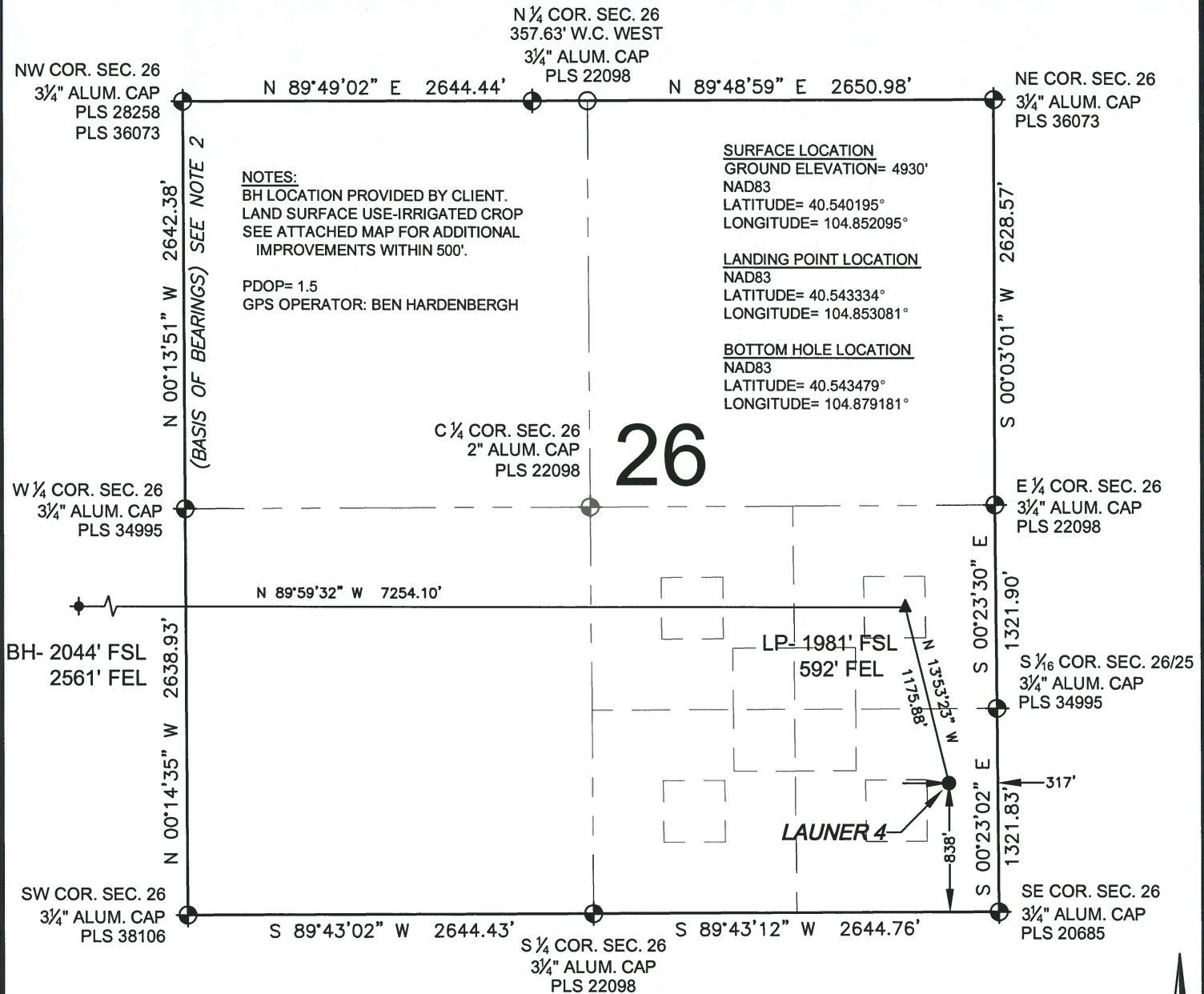


# WELL LOCATION CERTIFICATE: LAUNER 4

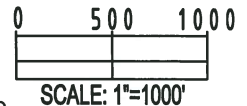

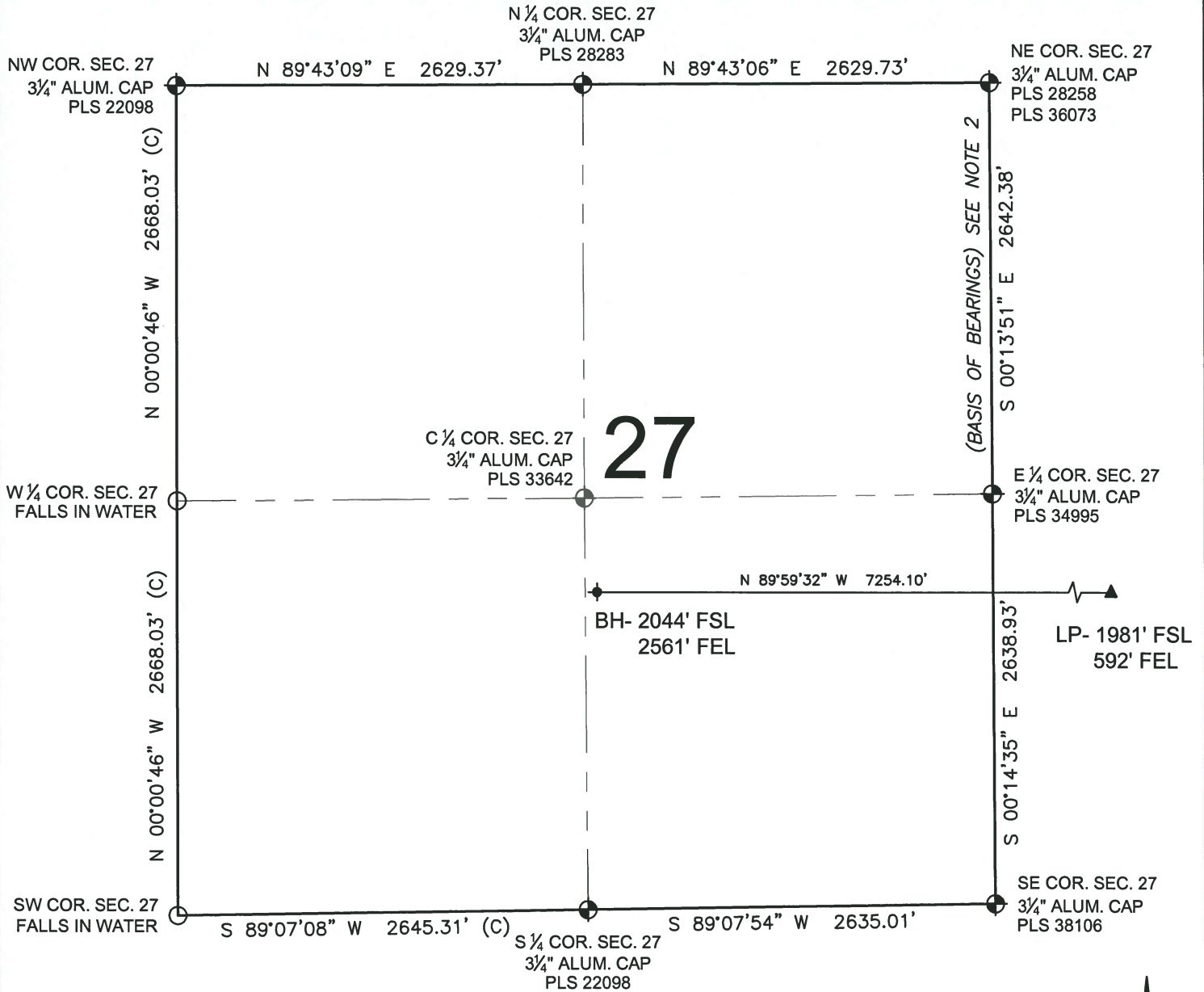

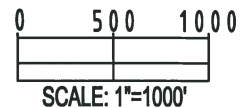
