I have Doug Andrews, OGLA Location Specialist with COGCC, attached to this email. He is reviewing our Orr State Pad and has some questions regarding our Wildlife portion.

Please provide information to the following questions regarding the meetings with the CPW for the Orr State Pad and involvement of Surface Owner:

1. For the 2A Orr State, did CPW wildlife, Brandon, provide any time line dates of when Synergy can be operating and can't be operating due to the wildlife in this location? If you can please script out this timeline and reply all that would be helpful for Doug Andrews to know so that he can make note as a special BMP for this wildlife location.
2. Per COGCC rules, I just need confirmation that the Surface owner was involved with the wildlife area, and with the CPW meetings for this location. Also I need to know the surface owner, Mr. Orr, has agreed to CPW's requests as well for this location. Similar to how we handled Williams Pad.

Thank you very much, and if you can respond today so that we can receive an approved 2A as quickly as we can that would be wonderful.

1. The CPW, Brandon, did not provide any restrictions and/or date windows associated with the wildlife in the nearby area. It was Brandon's intent to have Synergy start construction operations ASAP.

2. On October 7<sup>th</sup>, 2016 Mr. Orr was consulted and has agreed to CPW's request for the Orr State 40-36 Pad as follows but not limited to:

i. 30' sound wall  
surrounding the entire drill location during operations reducing light and sound impact.

ii. Security fence  
surrounding the perimeter of the production facility.

iii. Permanent sound  
wall to be placed around the compressor to reduce noise impacts.
