## COMMENTS:

Encana is providing a status update of the insitu remediation cell as described in document number 2210624, as part of REM #9307. Encana collected 23 soil borings from the remediation cell area to determine status and future activities needed in the area. The soil borings identified one sample to be above COGCC Table 910-1 standards (Total Petroleum Hydrocarbon), SBN 13-15 feet, with a TPH concentration of 1199.06 mg/Kg. During remediation cell construction, bedrock was encountered at 16 feet, stopping potential migration of impacted material. Encana will continue to complete insitu remediation of the cell and provide additional status updates to the COGCC when available.
