Extraction Oil and Gas, LLC (Extraction) is planning to drill the above referenced well in accordance with the provisions set out in Colorado Oil and Gas Conservation Commission (COGCC) Rule 318A.e. Extraction's Proposed Spacing Unit consists of:

S½S½ of Section 26, Township 7 North, Range 67 West
SE¼SW¼, S½SE¼ of Section 27, Township 7 North, Range 67 West
NE¼NW¼, N½NE¼ of Section 34, Township 7 North, Range 67 West
N½N½ of Section 35, Township 7 North, Range 67 West
Containing 560.00 acres, more or less.

Extraction is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(5). Copies of the required notification letters are on file at Extraction's office. The required thirty (30) day notice period has elapsed absent the receipt by Extraction of any objection to their proposal by the owners within the Proposed Spacing Unit for the subject well.

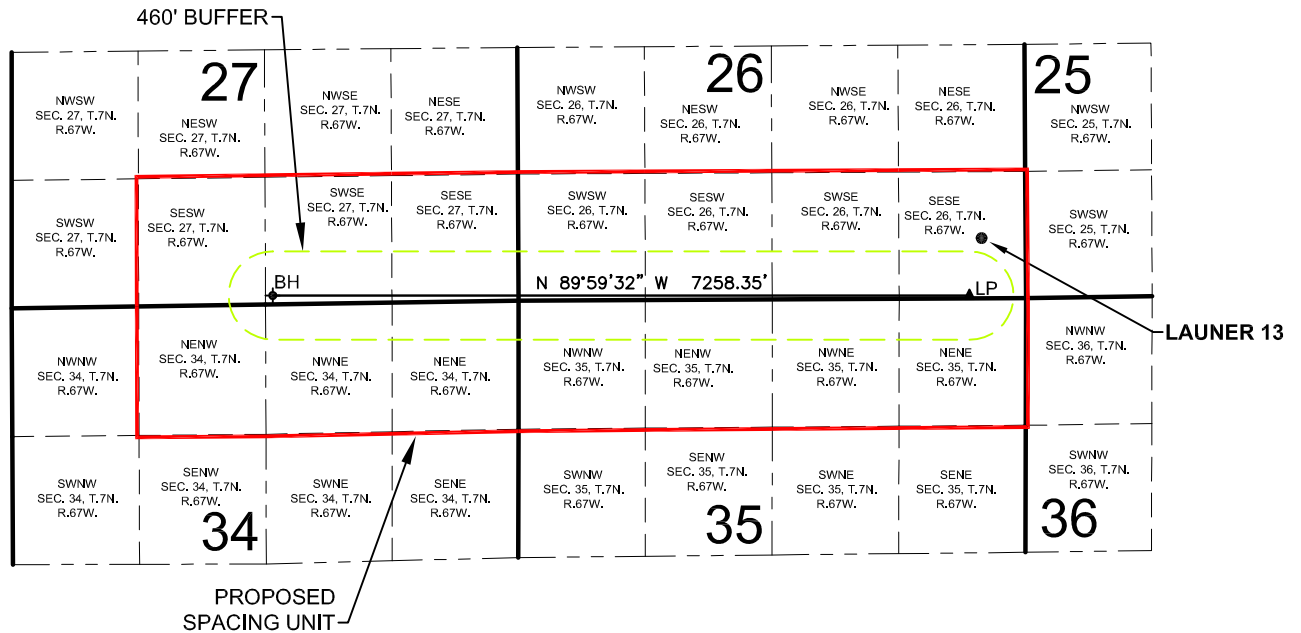

LANDING POINT LOCATION

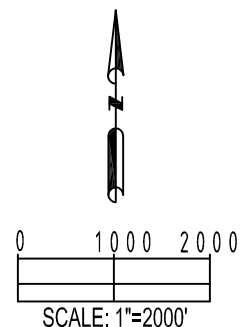
