COGCC Representative: SPOKE WITH ERIN DOUGHERTY FROM PDC SHE INDICATED SHE WILL HAVE STAFF LOOK AT ENTRANCE TO WELLHEAD IF WELLHEAD ACCESS IS ONLY ON ROAD PICTURED THEY WOULD CLEAN UP WEEDS IF ENTRANCE IS NOT THEY WILL PROVIDE PICTURES SHOWING ACCESS TO WELLHEAD.

COGCC Supervisor: REVIEWED DECISION WITH JASON GOMEZ. THIS IS THE ONLY ENTRANCE TO THE WELLHEAD LOCATION AND ACCESS IS UNAVAILABLE DUE TO A BUILD UP OF WEEDS BLOWING BETWEEN THE FENCES. HAD JASON NOTIFY PDC AND DISCUSS WHY HE WAS GOING TO DENY APPROVAL TO THEIR FIELD INSPECTION REVIEW.
