During completion operations, Laramie discovered the Bradenhead Pressure on the Federal 28-09M had exceeded 150 psig in less than 3 hours. Laramie conducted a brief shut-in of the BH and the pressure built to 480 psi after 12 hours. Laramie conducted an analysis of the gas from the BH and the results indicated the gas was coming from the MV zones the well is completed. In order to manage the bradenehad, Laramie requests approval to pipe the bradenhead gas to the combustor on location.
