Therefore the only producing well on the location is for 067-09365, which is a Samson well. Our records indicate that Elm Ridge is still the operator on record for the location. A Form 10 is needed to transfer ownership of the location to Samson. Elm Ridge will remain responsible for reclamation on the location until a Form 10 is received that transfers ownership of the location to Samson.
