Comments	<p>Total Equipment will include: One (1) Separators, One (1) Generator, Two (2) Compressors, Three (3) Meter Buildings</p> <p>Facilities are being used to stabilize the pressures within the pipelines. The location is servicing multiple production facilities to reduce pressure spikes which are currently slowing down production. It is currently unknown as to which production facility will be serviced as the location is intended to improve multiple production facilities and improve overall production down the line.</p> <p>This location will be adding pressure to the gathering line system, so that it has enough pressure to input into the midstream sales line. So it is intermediate on our lines, after metering at production facilities, but before hitting midstream sales lines. Without it, there isn't always enough stable pressure for gas to make it into the sales line. We aren't yet sure how far wide-reaching among the system or which locations within the gathering system will feel the benefits of pressure.</p>

Wastes will be temporarily stored in sealed containers and regularly collected and disposed of at offsite, suitable facilities. If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup of trash and discarded materials will be conducted at the end of each work day. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. BMP's used will vary according to the location, and will remain in place and maintained until the pad reaches final reclamation.
3	Material Handling and Spill Prevention	Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil & Gas operations throughout the state of Colorado in accordance with CFR 112.
