This Warning Letter is to inform you that PROWERS GAS GATHERING CO LLC ("Operator") may be in violation of the rules and regulations of the Colorado Oil and Gas Conservation Commission ("COGCC") and corrective action is required.

The COGCC has reasonable cause to believe that the Operator has committed one or more violations of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission. The Operator is required to comply with this Warning Letter by the **Corrective Action Deadline Date(s)** to resolve the alleged violation(s). Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1.

Alleged Violation(s) and Required Corrective Action(s):

312 Certificate of Clearance and/or Change of Operator

Description of Alleged Violation: Pursuant to Rule 312.i., a Form 12 Gas Facility Registration/Change of Operator shall be filed for gathering systems, gas processing plants, and gas storage facilities for proper registration and change of operator. The operator shall provide GPS readings in accordance with Rule 215.f. Operator is required to submit a topo map shall be submitted identifying the legal location of the gas compressor and a facility location drawing depicting all surface structures. COGCC records indicate that the NEU Compressor Facility #444661 located NWSW Sec17-24S-45W in Prowers County, Colorado is operated by Prowers Gas Gathering Company LLC – Operator #72190 (Operator) but no Form 12 has been submitted to reflect this operatorship, violating Rule 312.i.

Required Corrective Action: Operator shall complete and submit the following: a) Form 12 Gas Facility Registration/Change of Operator for the NEU Compressor Facility #444661; b) Topo map identifying the legal location of the gas facility; c) Facility location drawing depicting all surface structures; and d) Provide GPS NAD 83 readings for this gas facility.
