1	Planning	In compliance with Rule 317.p the first well that is operationally feasible on the Mesa F26-697 pad will be logged with an open-hole Resistivity Log and Gamma Ray Log from TD into the surface casing. All wells on the pad will have a Cement Bond Log with cased-hole Gamma Ray run on the production casing. The Form 5 Completion Report will list all the logs run in the subject well and identify the well that was logged with the open-hole Resistivity Log.
2	Drilling/Completion Operations	Closed loop system will be used. No pits will be built. Caerus will ensure 110 percent secondary containment for any potential volume of fluids that may be released.

Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. All permitted water wells within the search radius show zero for reported depths. Depths to formation tops in offset oil and gas wells, locally-available geophysical logs, and hydrogeologic information was used to evaluate the adequacy of the operator's proposed surface casing setting depth. Review of offset logs and geologic mapping indicates the proposed surface casing will cover the entire Parachute Creek member of the Green River formation.
