Bison Oil and Gas, LLC respectfully requests confidential status for the drilling, completion, and production of the Bison 4-64 15-16 2BHZ horizontal well on the basis of new stimulation and drilling techniques in an area that has geologic and economic risks. Bison will be utilizing the AutoTrak technology which is a new rotary steerable tool that improves wellbore steering and can help reduce wellbore peaks and valleys. Also, the offset wells in the region used sliding sleeve and swell packer isolation technology that resulted in poor economic and production results, whereas, Bison will be utilizing a cemented monobore system that is expected to yield economic results that could cause offset areas to become economically prospective again. In addition, Bison will also be implementing an enhanced stimulation design which includes increased fluid volumes, sand placement, and increased perforations clusters which is substantially different than any wells in the offset area. Bison believes that poor performing designs used in the offset wells to the east have condemned the area and no new permits have been filed east of the Bison permitted well; therefore, if Bison is operationally and economically successful, the confidential status would allow for Bison to possibly grow their position in directly offset acreage.
