Comment: Well file records indicate well was PA 6/17/2011. No PA marker visible above ground records indicate buried marker installed. No evidence of leaking noted at surface at time of inspection. Location and surrounding area comprised of cedars, oak brush, and grasses. Location has evidence of growth and total revegetation appears to be underway. Access road dirt work looks good but there is little evidence of vegetation and may require additional soil preparation and seeding in spring 2017.
