Pursuant to the Conditions of Approval (COAs) associated with Sandridge Energy's Final Subsurface Environmental Site Investigation Report for the Mutual 4-30H (API No. 05-057-06488) which was approved by the COGCC on October 20, 2016, this is to inform the COGCC that SandRidge will implement the soil shredding and chemical oxidation option to remediate the on-site subsurface drill cuttings in lieu of their off-site disposal. SandRidge anticipates commencing remediation activities on or about June 1, 2017.

In the event chemical oxidation and soil shredding fails to remediate the contaminant levels in the drill cuttings below those prescribed in Table 910-1, SandRidge will then dispose of the cuttings at an off-site commercial disposal facility.
