You are granted the extension until 10/15/16, however, I am adding an additional COA to the Intent as follows:

"Prior to initiation of plugging operations, a Bradenhead test shall be performed. If any pressure remains at the conclusion of the test or any liquids were present call COGCC Engineer for sampling requirements. Form 17 shall be submitted within 10 days."
