Retainer set at 7175' and topped with cement. Bridge plug was then set at 5325' and topped with 2 sxs with top of cement at 5302'. Well filled with water and preped for MIT. Final test pressure was to be 5000 psi. Well was pressured up incrementally to attain test pressure. Pressured up to 250 psi and held for 5 min. Stepped up to 1000 psi for 5 min, 2000 psi for 5 min, 3000 psi for 5 min, and the pressured up to 5000 psi for 30 min. Starting pressure 5000 psi and ending pressure of 5000 psi. No loss of pressure noted. Operator will submit completed Form 21 and Chart.
