**General Comment:**

On October 5, 6, and 11, COGCC staff conducted site inspections during a monitoring wells drilling operation. On site with Brett Middleton from Encana/Hunter Ridge; Wesley Toews and Dustin Held from LTE. (see REM #9748) The drilling operation was conducted to complete the Phase III Environmental Assessment, document submitted to the COGCC on 10/06/2016 (doc #401125566). A rotasonic drilling rig was used to improve core sampling recovery and well construction. Poorly cemented sandstone was encountered mostly on monitoring wells on both sides (east and west) of the valley. Clayey soil was encountered on monitoring well MW13 in the valley, on the east side of the creek. LTE personel developed wells drilled few days before. Photos (attached) show free product recovery during bailing operation at the MW-20 monitoring well.
