PROPOSED UNDERGROUND INJECTION
CONTROL PERMIT

PURPOSE OF PUBLIC NOTICE:

The purpose of this notice is to solicit public comment on the EWS #3A injection permit submitted by Expedition Water Services Colorado LLC. The EWS #3A is a new directional well being drilled expressly for commercial EPA-Class II disposal. The proposed surface drilling location is 2,528 feet from north line and 1,045 feet from west line of SWNW of Section 23, Township 4 North, Range 66 West, 6th P.M., Weld County, Colorado. The planned bottomhole location is in Section 26 approximately 2,556 feet from north line and 512 feet from east line.

BACKGROUND

Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploratory and production operations. Expedition Water Services Colorado LLC proposes to inject these fluids into the Lyons, Lower Satanka, Wolfcamp, Amazon, Council Grove, Admire, Virgil, Missouri, and Fountain Formations in the EWS #3A through an open-hole completion using a slotted liner. Injection depths will be from approximately 11,024 to 12,766 ft measured depth.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning proposed injection well permit, the Director may request that the Commission hold a hearing on the matter.

Additional information on the operation of the proposed injection well may be obtained at the Commission office.
