Recontour location and establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/30/2016

Operator Comment: QEP cut the casing off 4 ft below surface and welded on a name plate. The location was recontoured, disced, and seeded. The reclaimed area was fenced. A reclamation summary and photos are attached.
