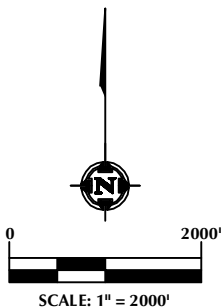
# AG 32C-31-L WELL BORE SPACING UNIT
