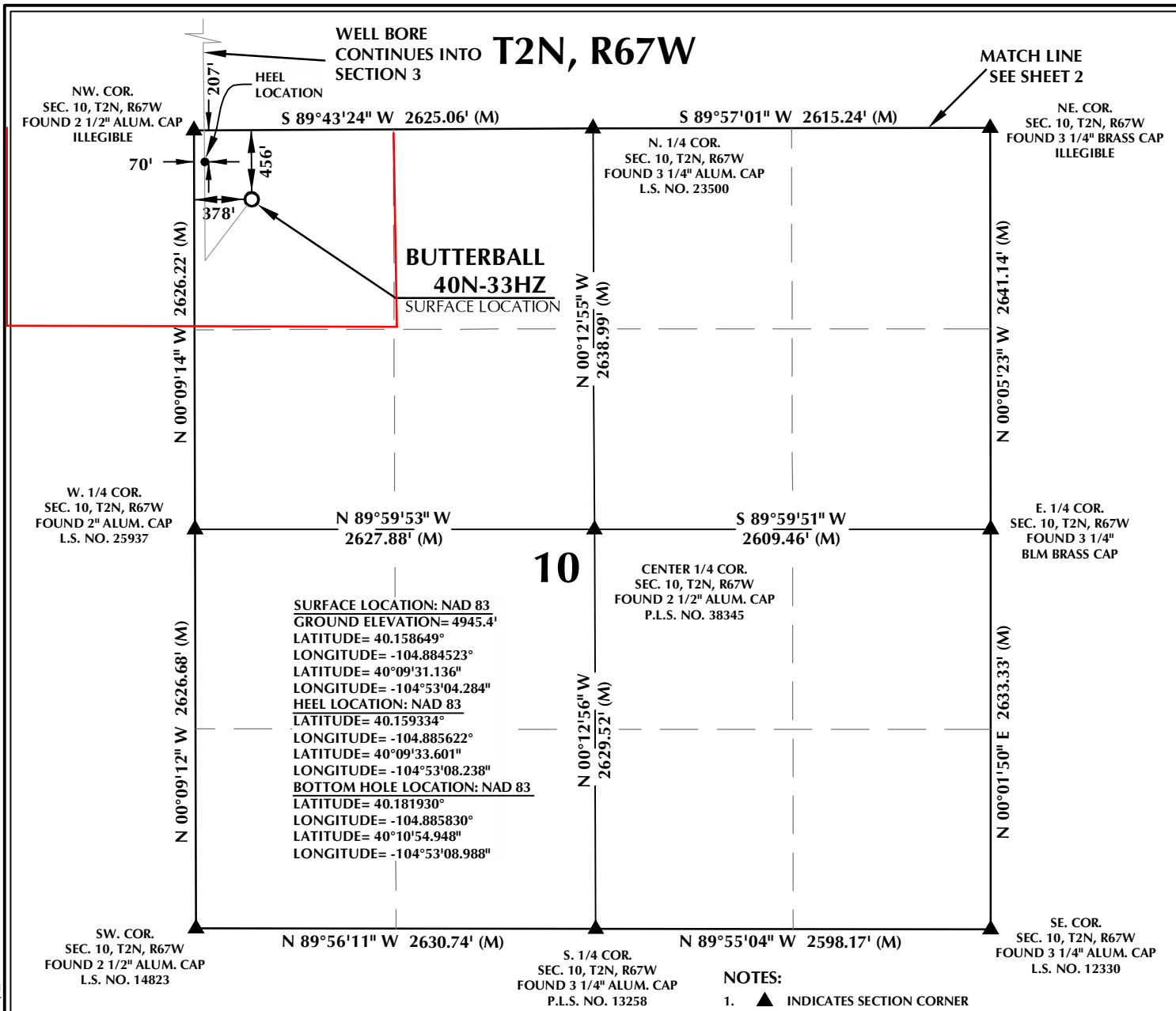

PROPOSED SPACING UNIT

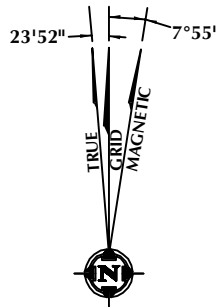
