Wattles become Debris when no longer needed for stabilization of site; Location cannot be Released for Final Reclamation when these Temporary SW controls are still in Place. Senesced/Desiccated Noxious Weeds (Plumeless Thistle) are scattered across location. These plants in Growth stage are visible in Vegetation Monitoring Photos attached to Form 4. Access road has not been Reclaimed. Thistle plants line West side of Road. Refer to Photos Attached for more Detail.
