

**NOTICE OF PROPOSED DESIGNATION OF THE DAKOTA AND LAKOTA FORMATIONS AS EXEMPT AQUIFERS**

**TO ALL INTERESTED PERSONS AND TO WHOM IT MAY CONCERN:**

The purpose of this notice is to solicit public comment on the JUDY 1-30 disposal well, a Class II injection permit submitted by Sandridge Exploration & Production LLC. The JUDY 1-30 disposal well is being converted from a production well that was drilled at a location 2,164 feet from the south line and 790 feet from the east line of Section 30, Township 7 North, Range 80 West, 6th P.M., Jackson County, Colorado.

Class II injection wells are permitted and regulated in such a manner as to prevent the contamination of underground sources of drinking water and to ensure fluid emplacement and confinement within the permitted injection zones. Class II injection wells are permitted to inject waste generated from oil and gas exploration and production operations.

Sandridge Exploration & Production LLC proposes to inject these fluids into the Dakota and Lakota Formations in the JUDY 1-30 well through perforations at depths of approximately 7,730 to 7,902 feet.

The Dakota Formation occurs at depths of 7,730 to 7,829 feet and the Lakota Formation occurs at depths of 7,829 to 7,904 feet in the JUDY 1-30 well. Analysis of water for total dissolved solids (TDS) from the Dakota and Lakota Formations indicates a TDS content of approximately 3,900-4,000 mg/L (mil-

ligrams per liter). Water for this analysis was collected from the nearby Vaneta 1-32D well (1.1 mile to the southeast). Because the TDS content is less than 10,000 mg/L, an aquifer exemption is required. Note that the Dakota and Lakota Formations have also been exempted in the Vaneta 1-32D well.

Based on the data supplied by the operator, the Dakota and Lakota Formations would qualify as exempt aquifers under this Commission's Rule No. 324B.a in that:

They do not currently serve as a source of drinking water; and

They cannot now and will not in the future serve as a source of drinking water because:

They are situated at a depth and location which makes recovery of water for drinking water purposes economically or technologically impractical under current practice. The subject aquifers are at depths of between 7,730 and 7,902 feet.

It is so contaminated that it would be economically or technologically impractical to render the water fit for human consumption.

The TDS content of the ground water is more than 3,000 and less than 10,000 mg/L and it is not reasonably expected to supply a public water system. As stated TDS in the water samples taken range from 3,900 to 4,000 milligrams per liter.

The cost to drill a water well to the Dakota and Lakota Formations would exceed \$1 million, and the practical likelihood of this happening would be low.

The application exemption will include the W 1/4 of the SW 1/4 of Section 29, the SW 1/4 of the NW 1/4 of Section 29, the S 1/2 of the NE 1/4 of Section 30, and all of the SE 1/4 of Section 30 Township 7 North, Range 80 West, 6th P.M., Jackson County, Colorado.

Public comments are encouraged and will be accepted, in writing at the Commission for a period of thirty (30) days after publication of this notice. If any data, information, or arguments submitted during the public comment period appear to raise substantial questions concerning this proposed injection well permit or the accompanying aquifer exemption, the Director may request that the Commission hold a hearing on the matter.

If, within thirty (30) days after publication of this notice, the Commission does not receive a hearing request, which indicates there is a significant degree of public interest in a hearing on the designation of the aquifer exemption, and the disposal well permit is approved, then the Dakota and Lakota Formations in the limited area described herein shall be considered exempt.

If, within thirty (30) days after publication of this notice the Commission receives a hearing request, which indicates there is a significant degree of public interest in a hearing on the designation of the aquifer exemption or portion thereof as exempted, then the Commission shall hold such a hearing as soon as practicable and shall make a final determination regarding the designation.

She married Raymond Franklin Wyatt Aug. 23, 1944. They had four children; three sons: Richard, Rodney and Russell, and one daughter, Wray.


