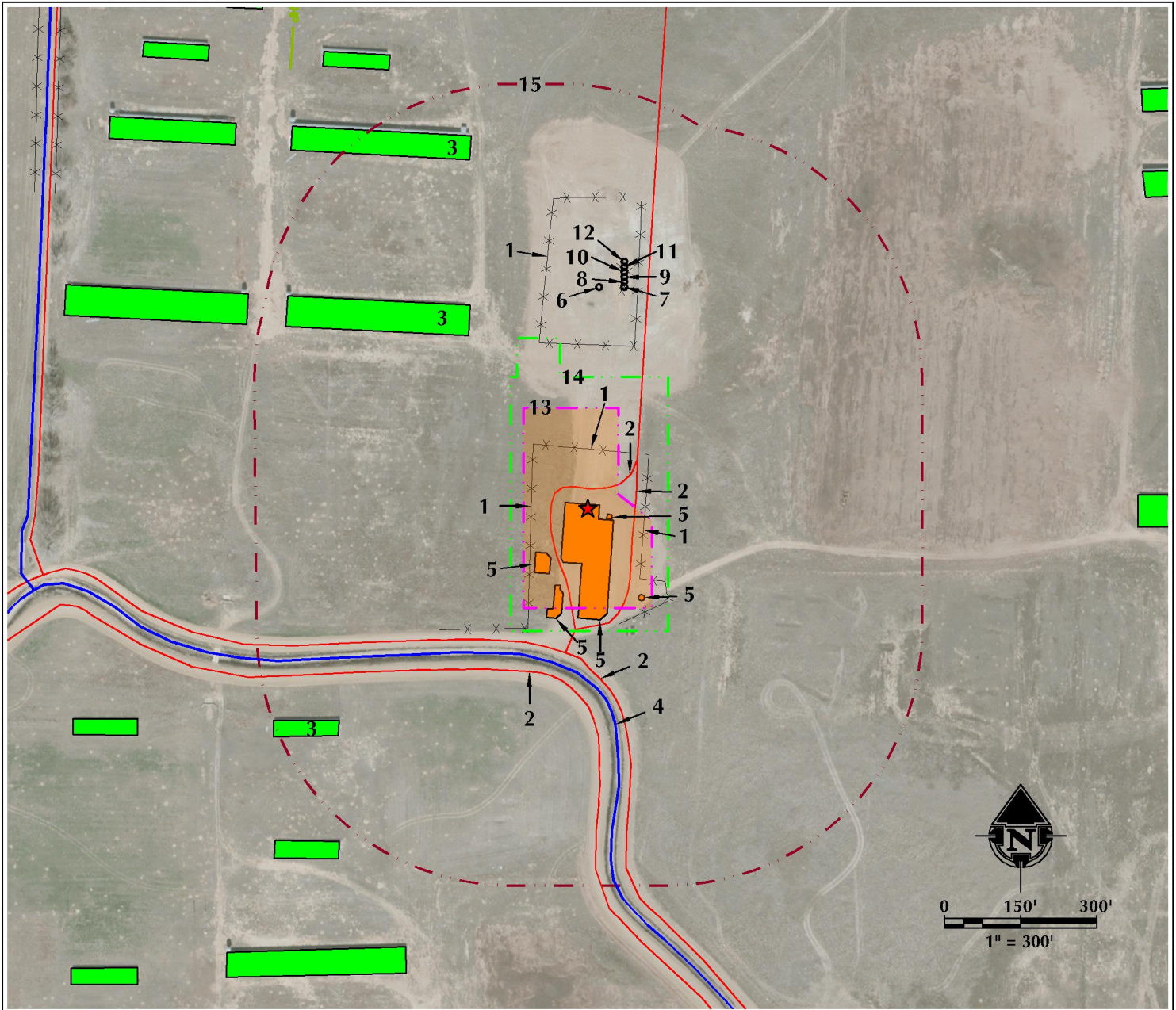


LOCATION DRAWING BUTTERBALL 25C-34HZ FACILITY PAD
